Dear farmland preservation practitioners,

As we move into the drafting of a new federal Farm Bill, it's important to be able to tell our success stories to policy makers and others that support our work. The discussions about the future of the Farm Bill's various programs are already happening as Congress faces the pressures of finding ways to relieve the national debt. For those of us in the farmland preservation community, that means sharing our stories about how the Farm and Ranchland Protection Program is helping us with our work.

Brian Bourdages, Farmland Protection Specialist at the Grand Traverse Regional Land Conservancy, is serving as the point person to collect these success stories. Together with Heart of the Lakes Center for Land Conservancy Policy, American Farmland Trust, Land Trust Alliance and our other friends, Brian will make sure they are shared in manner that might best help us to continue to garner FRPP funding for our projects throughout Michigan.

Brian has been told by congressional staffers working on the Farm Bill and others working in this regard that the following three types of anecdotes or letters of support are most important:

1) Projects involving FRPP where a farm family or business was able to use the proceeds to expand their operation or create new agri-business activity that contributed to job creation.

2) Projects involving FRPP that clearly facilitated the transfer of

the farm, or portions of the farm to the next generation of growers or to beginning farmers.
3) Letters that demonstrate how farmland preservation is bolstering

the environment for agri-business and/or infusing confidence in the agricultural community by instilling confidence that sufficient land will remain available for production over the long run.

One way to garner this type of support is by soliciting letters from community members or families that you have worked with that speak to the issues outlined above. I'm attaching two letters that were received recently by the Grand Traverse Regional Land Conservancy as examples.
