### APPROVAL OF MINUTES

**09-1244** Council Liquor License Review Committee - November 13, 2009

**09-1239** Resolution to Approve the Transfer of Ownership and Location of a 2009 Class C Liquor Licensed Business, a New Dance Permit, a New SDM Liquor License and Outdoor Sales and Service, located at 575 Briarwood Circle - D/B/A Red Robin Gourmet Burgers

**Committee members reviewed the application by Red Robin Gourmet Burgers. There were questions regarding the need for a Dance/Entertainment Permit and a SDM license.
