HICKORY NATURE AREA ZONING  
(2817 DILLON DRIVE)

AN ORDINANCE TO AMEND THE ZONING MAP, BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:

Section 1. THE ZONING MAP, which, by Section 5.10.2 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Commencing at the West ¼ corner of Section 16, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan; thence N00°26'45"E 667.77 feet along the West line of said Section 16 to the Point of Beginning; thence continuing along said West line N00°26'45"E 587.67 feet; thence N26°01'04"E 88.67 feet; thence N88°00'11"E 258.14 feet; thence S01°52'53"E 125.02 feet; thence 13.13 feet along a curve to the left, said curve having a radius of 125.00 feet, a delta angle of 6°01'11" and a chord bearing S84°32'54"W 13.13 feet; thence N08°27'41"W 112.00 feet; thence S72°54'42"W 71.10 feet; thence S55°39'28"W 71.10 feet; thence S38°30'08"W 70.32 feet; thence S30°17'42"W 45.00 feet; thence S27°12'44"W 56.16 feet; thence S18°19'48"W 91.02 feet; thence S00°24'44"W 137.21 feet; thence S22°29'37"E 84.64 feet; thence S47°07'17"E 84.15 feet; thence S72°30'14"E 84.37 feet; thence N88°07'57"E 435.34 feet; thence S01°52'03"E 63.08 feet; thence S87°57'33"W 639.65 feet to the Point of Beginning. Containing 2.07 acres, more or less.

in the City of Ann Arbor, Washtenaw County, Michigan as PL (Public Land).

Section 2. This ordinance shall take effect and be in force on and after ten days from legal publication.
