It recently came to our attention that Mr Fraser was not in support of the grant because he believes there will be further layoffs. 



I am writing concerning the Ann Arbor Residential Parking Permit Program. I live in a 40-unit apartment building at This building has a very small parking lot that accommodates approximately 4-5 cars. I have therefore been parking on the street since I moved into the building in August 2009. I was not aware until I returned to Ann Arbor last weekend that a residential parking permit program had been created. Today, I went to go purchase a parking permit and was told that the allotment for my building had already been reached and that I therefore could not purchase a permit.

I am writing to ask that you please expand the allotment for my building. The Residential Parking Permit website states: "The Residential Parking Permit (RPP) program allows vehicles owned by residents to park in an RPP neighborhood for the posted time limit without being ticketed." I am a resident of an RPP neighborhood and it is not acceptable that I am not being issued a permit so that I may park near my home. It is not an adequate solution for me to have to move my car from one side of the street to the other every day. I am a busy graduate student in the field of Public Health and do not have any other options for parking within a reasonable distance to my apartment. I would greatly appreciate your quick attention to this matter.

Bob,

I received your letter to the Mayor and City Council from Sandy Arlinghaus and I'm surprised that she didn't mention that the City has no plans to sell the Huron Hills Golf Course or any other park land. I'm currently on the Parks Advisory Commission and at our last meeting we reviewed the RFP which the City has just released for bid. The request is rather specific in that it states:

"The City is seeking creative proposals to maximize the recreational golf opportunities available at HHGC to the community. Currently, HHGC operates as an 18-hole course with 7 holes north of Huron Parkway and 11 holes south of Huron Parkway. The land may remain similar in layout to its current form, or may be recommended for alternative (any physical improvement or alteration to the course shall retain as its function recreational golf) golf use in the submitted proposal. The City will retain ownership of the buildings and property, and any improvements will become the property of the City. All proposals, whether based on the existing course design or an alternative design proposal, must incorporate the following principles:

- 1. Commitment to growing the game of golf.
- 2. Conduciveness to entry level golfers.
- 3. Accessibility and affordability of recreational golf opportunities, especially for children and seniors.
- 4. To better serve the Ann Arbor golf community."

I added the bolding. The intent of the RFP is to solicit ideas for how the golf operation at Huron Hills can be run more effectively and perhaps more profitably than we are currently. I, and probably everyone on PAC, believe that the current staff is doing an excellent job, but since questions do arise about the profitability of the course, we concur with City Council and the City Administrator that we would benefit from testing the waters and seeing what alternatives exist.

If you would like to speak about this further, please let me know.

# September News Briefs on September's Theme: Tuesday Venue Safety and Patron Responsibility News

#### STAY UP-TO-DATE ON GLOBAL NIGHTLIFE NEWS

This month's news stories feature cities with innovative strategies to address underage drinking, over-service and safety within venues, as well as strategies for mobilizing nightlife stakeholders as collaborative partners.

#### NIGHTLIFE VIOLENCE SPURS ACTION IN PITTSBURGH

**Pittsburgh**, **PA** – After a recent shooting in the South Side area, City Councilman Bruce Kraus emphasized the need for the city of Pittsburgh to change the way it manages nightlife. Currently, the city "has provided garbage receptacles, deployed police bicycle patrols and taken other measures to help the community," but Kraus asserts the city will need to make additional changes to <u>resolve safety challenges</u>. Recently, his administration released a comprehensive plan of suggestions on topics such as public transportation, a parking strategy and late-night code enforcement.

#### EXTENDING BAR CLOSING HOURS AND LICENSING BUSKERS

**Edmonton, AB** – A group of residents, club operators, landlords, police, non-profits and other organizations on Jasper Avenue have created a list of <u>nightlife recommendations</u> for the city. Among the priority action steps is to allow bars to stay open until 4 a.m., but still cut off alcohol sales at 2a.m., in order to reduce the "rush hour" that occurs with a common closing time. The group also proposes the creation of a standard disclosure form to inform new residents of nightlife activity in the area before they move in, since the area around "a building that doesn't look very active in the daytime might be very much different at two in the morning." Additional recommendations include a dedicated police unit and licensing street performers to increase the diversity and quality of the performers.

#### VIDEO ON THE IMPACT OF NIGHTLIFE ACTIVITY ON RESIDENTS

Brighton and Hove, England – City Councilor Kitcat has released a <u>video</u> online depicting what a typical Friday night is like on East Street and how it <u>affects the residents' quality of life</u>. Part of a broader initiative, an "inter-agency summit" has also been proposed to create solutions for noise and safety challenges in the nighttime economy. Summit participants will consist of council officers, police, club managers and residents. Representatives hope to rely "on the good relations (already) established with some of the venues in the street" to move progress forward.

#### ROWDY PARTIERS IN SEATTLE FACE TICKETS

Seattle, WA – City council in Seattle has passed a new law allowing police officers to issue <u>civil infractions</u> to people in "nightlife zones" located in urban areas such as Belltown. Police will now be able to write tickets for up to \$100 to individuals who create unreasonable amounts of noise, threaten others or fight between the hours of midnight and 5a.m. The law is part of a more comprehensive plan that Mayor Mike McGinn has recently unveiled for nightlife in Seattle, such as a proposed extension of bar closing time

#### NY NIGHTLIFE CLUB OWNERS BASH NUISANCE POINTS SYSTEM

Rochester, NY – The city council in Rochester has voted to place a six month moratorium on the <u>nuisance point system</u> used for nightlife establishments due to allegations that the system is complicated, unclear and ineffective in addressing safety and quality of life challenges. The point system assigns points to establishments for illegal activities such as drug offenses, gambling, and prostitution. An accumulation of points can lead to closing the business. Some business owners allege that police officers are inconsistent in their decisions to fine or issue points to an establishment. Due to current challenges, business owners, city council members and community residents are pushing to create an advisory board to evaluate and oversee the distribution of points in the future.

#### CRACKDOWN ON NIGHTLIFE VIOLENCE IN AUSTRALIA

Brisbane, Australia – A new plan released by Premier Anna Bligh in Queensland proposes a 40% increase in police officers on patrol and new legislation to ban troublemakers from entertainment areas. The Drink Safe Precincts trial, a statewide strategy to combat incidents in key entertainment areas, follows a 12-month parliamentary inquiry into alcohol-fueled violence in nightclub areas. Many recommendations have already been implemented, including a provision requiring businesses to provide free water for patrons in nightclubs and designated "safe zones" for anyone in distress. On Friday and Saturday nights the area will have a coordinated response team consisting of police, venue staff, paramedics and welfare workers.
