Renee Bush of the Ann Arbor Police Department stated the Police were not objecting this year to any annual renewals, but did note that PD is working with Scorekeeper's Bar on an Education Plan regarding underage drinking. She also stated many of the calls to service at Siam Square's location, were not related to the restaurant or the liquor license, but were actually connected to activities in the adjoining hotel.*

*Councilmember Westphal moved, seconded by Councilmember Kailasapathy, that the recommendations of the City Treasurer to send objection letters to the above listed businesses, with a payment due date of January 26 to avoid further action of the Committee, be approved. On a voice vote, the Chair declared the motion carried.*
