SERVER TRAINING CERTIFICATION

An applicant for a new on-premises license or transfer of more than 50% interest in an existing on-premises license under MCL 436.1501(1), must file with the Commission proof of server training certification of at least supervisory personnel within 180 days of the issuance of the license if that is a condition imposed through the approval order. As a continuing requirement, the on-premises licensee must employ these trained supervisory personnel, who have been trained through an approved server training program pursuant to MCL 436.1906, on each shift and during all hours in which alcoholic liquor is served. **Failure to provide Server Training Certification may result in suspension of the license.**


