**9-a. 23-2081 333 East William Street Site Plan**

Site Plan for City Planning Commission Approval. A sixteen-story, 202 dwelling unit residential building with four surface parking spaces accessed from E. William Street. Zoning Designation: D1 (Downtown Core) and Liberty/Division character overlay district and Secondary Street frontage designation. The total floor area is 230,126 sq ft. Staff Recommendation: Approval.

*Andrew Savoy presented the proposed request.*

**STAFF REPORT:**

*City Planner Chris Cheng presented the staff report for the proposed request.*

**PUBLIC HEARING:**

*-Ronald Nelson, who works at 337 E. William Street, asked whether the pool could be designed to ensure objects can't fall, if it will be indoor or outdoor, and if it could be moved to the other side of the building; an additional inquiry was made as to whether a fence would be provided along the property line adjacent to the easement.*

*-Ken Garber, 28 Haverhill Court, urged the City to include building electrification in the project's development agreement.*

*-Samuel Hayes, Ypsilanti resident, expressed affordability concerns, stating that \$1,899 for a one person apartment is too high. Working in*

*Ann Arbor in a union environment, they find that many co-workers cannot afford to live in Ann Arbor. Would like to know how the project helps to address homelessness, and concurred with previous two commenters.*

*-Brandon Dimcheff, 4th Ward resident, spoke in support of proposed project and spoke in favor of formalizing the commitment to building electrification.*

*-Alex Lowe, resident, spoke in support of the proposed project, stating it will provide an aesthetic improvement to the block, and they wished the building were taller.*

*-Adam Goodman, 400 Virginia, spoke in support of the proposed project, stating Ann Arbor has a housing crisis; they would like to see this project take advantage of height bonuses.*

*Seeing no additional speakers Chair Lee closed the Public Hearing.*

*- Ken Garber, 28 Haverhill Court, shared insight into the original project to build the credit union which will now be replaced. It was considered a controversial project at the time because it replaced houses, but now we have come full circle. Thanked the Planning Commission for all they do.*

*-Samuel Hayes, Ypsilanti resident, expressed concerns about affordability and developer claims for the 1208 S University project - in particular the business viability of Pinball Pete's and their right to return as a tenant of a new development. Caller agrees that more housing will help the housing crisis, but not at such high prices; expressed concern that the Galleria / 1208 S University developer had not spoken to Pinball Pete's despite claims otherwise. Thanked the Planning Commission for their work.*

*Seeing no additional speakers Chair Lee closed the Public Comment.*
