AND FOR SIDEWALK REPAIR AND CONSTRUCTION

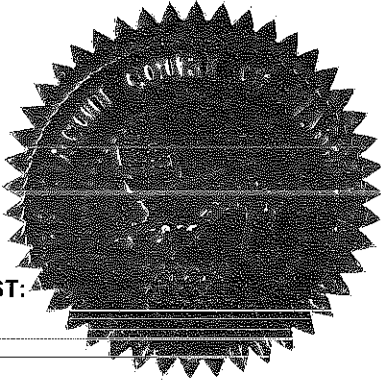
