- 1. Thomas Partridge - Honor 9/11 families. Protect America's most vulnerable. Recall Governor Snyder. Fully fund affordable housing, public transportation, healthcare and education. (DS-2, I-7)**

Thomas Partridge, Ann Arbor resident, addressed Council regarding the victims of 9-11 and their families, protecting America's most vulnerable citizens, recalling Governor Snyder and fully funding affordable housing, public transportation, healthcare and education.

- 2. Shelly Smith - Medical Marijuana appeal (E-1)**

Shelly Smith, 11827 Eriksen Dr., Pinckney, Michigan, addressed Council regarding the recent court decision ruling against medical marijuana dispensaries. She said that it is not good for Ann Arbor or the Michigan economy (loss of jobs and vacant buildings), democratically (voters voted in favor to have safe legal access to the medicine) and patient access would be restricted.

- 3. Mark Passerini - Medical Marijuana Board (E-1)**

Mark Passerini, 710 W. Stadium, said that the recent court decision has forced tens of thousands of patients statewide back into a state of limbo. The intent of the Michigan Medical Marijuana Act was to afford patients safe access to medicine. He added that dispensaries need to be a viable solution for the future of medical marijuana.

- 4. Koos Eisenberg - Medical Marijuana (E-1)**

Koos Eisenberg, 350 Briarwood Dr., Apt 163, a medical marijuana patient, said that having dispensaries is important to her because of security and safety, education, sense of community, and an alternative to individual patient caregivers. Dispensaries also provide alternative forms of medical marijuana, besides plants.

- 5. Francesa Loria - Medical Marijuana (E-1)**

Francesa Loria, 1581 S. Main St., addressed Council regarding medical marijuana dispensaries. She said that keeping medical marijuana safe and accessible through legitimate dispensaries is an opportunity, not a detriment to Ann Arbor.

- 6. Dori Edwards - Medical Marijuana (E-1)**

Dori Edwards, 2904 Maplewood Ave., spoke in support of medical marijuana dispensaries and thanked Council for allowing dispensaries in the City. She said that the Ann Arbor dispensaries are within the law and they are trying their best to follow the law and to keep patients safe and to give them good clean medicine. Ms. Edwards also thanked the Mayor for the appointment of members to the licensing board.

7. Lili Au - Human Services Fund (DS-7)

Lili Au, 682 Peninsula Ct., spoke in opposition of the Countywide coordinated funding plan for human services.

8. Libby Hunter - Fuller Road Station

Libby Hunter, 827 Bruce, serenaded Council in a song opposing the Fuller Road Station.

9. Chuck Ream - Medical Marijuana (E-1)

Chuck Ream, 1818 Packard St., said that his Ann Arbor business was recently attacked in broad daylight and robbed by police. He said that no warrant was provided and no charges were ever filed. They stole all his medical marijuana medicine, stole what was at the bank and stole the license application that he had just received from the City of Ann Arbor to become a licensed dispensary. He said that the City should defend the City Charter of Ann Arbor that was approved by voters.

COMMUNICATIONS FROM COUNCIL**COUNCILMEMBER SMITH**

Councilmember Smith said that she is sponsoring an ordinance regarding video surveillance, which should be ready for September 19. The ordinance will specify where cameras cannot be, including residential areas. She also announced two events that would be happening in Kerrytown. The Homegrown Festival is scheduled for September 10, 2011 and the OutFest is scheduled for September 17, 2011.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that the Ann Arbor Housing Commission has not had a Council liaison in a while. He volunteered to become the Council liaison for the Ann Arbor Housing Commission.

COUNCILMEMBER BRIERE

Councilmember Briere announced that she plans to bring a Resolution of Intent to the next meeting regarding the streets and sidewalk millages that are on the November 2011 ballot. The Resolution of Intent should clarify how the Council and the City expect to account for and spend the millage monies.

COUNCILMEMBER TAYLOR

Councilmember Taylor said that at the last Park Advisory Committee (PAC) meeting there was a conversation about the proposed Fuller Road Station and its interface with the border-to-border trail. PAC is interested in the promotion of the border-to-border trail and its relationship to the recreational amenities associated with the City. PAC identified a number of priorities in their resolution, first being the trail improvements contemplated in connection with Fuller Road and the Fuller Road Station, and requested that those improvements be prioritized over bicycle station

amenities within the structure.

COUNCILMEMBER DEREZINSKI

Councilmember Derezinski noted that September 7, 2011 is the ribbon-cutting ceremony for the Washtenaw Avenue Path. The ceremony is scheduled to start at 2:30 p.m. Councilmember Derezinski noted that the path is really looking nice and adds to the City's accessibility options for non-motorized transportation.

MAYOR HIEFTJE

Mayor Hieftje said that the Park and Ride Lot at Plymouth Road and US 23 was busy on the first day it opened and is continually being used in the way that it was designed.

Mayor Hieftje announced that Councilmember Anglin could not attend tonight's meeting and stated he sends his regrets.
