*Ginny Trocchio said that everyone is gearing up for the 2012 Farm Bill that is under negotiation now. MDA and others have pulled together all of the PDR Programs within the state and are asking for statements on how the Farmland and Ranchland Protection Program (FRPP) has helped them. Ms. Trocchio said that she would be working with landowners to get letters of support for the program and would also like to get a letter from GAC, stating how the program has helped them achieve their goals and succeed and leverage other dollars.*

**A motion was made by Commissioner Riseng, seconded by Commissioner Allen, to direct staff to create a letter in support of the FRPP program. On a voice vote, the Chair declared the motion carried.**

*Ginny Trocchio said that the commission talked about goals/deliverables for next year. One of those deliverables was to come up with a communication plan on how to better reach Ann Arbor residents. She said that the program has reached a point where they have accumulated a lot of projects and acres protected and have been good at articulating those successes in acres protected and dollars leveraged. The executive committee has suggested working with Communications staff at the City to come up with more branding and logo for the Greenbelt Commission and the Greenbelt Program itself. She added that she was looking to have a subcommittee meet a couple of times to brainstorm and get a better direction from the commission as to which way to proceed. Commissioner Rother volunteered to sit on the subcommittee.*
