H. Hanzel, City of Ann Arbor Park Planner/ Landscape Architect, explained the request for a recommendation to submit a grant application to the Michigan Department of Natural Resources (MDEQ) for Universal Access improvements proposed at Argo Livery. Hanzel explained that the concept for proposed improvements is to make changes to the infrastructure to make the space accessible to all people, regardless of age, disability or other factors. She further explained that the improvement proposal includes the addition of an accessible launch, accessible pathways, an accessible picnic area, paving a parking lot and providing ADA parking spaces, and renovations and an addition to the

restrooms to make them accessible. Other site improvements include using green infrastructure such as bioswales and rain gardens to manage stormwater runoff on site.

Commissioner R. Skylis inquired about plans for accessible restrooms.

Hanzel explained that the architect for the project will be designing the restrooms to ADA code as well as exploring opportunities for additional improvements.

L. London inquired about the timeline.

Hanzel explained that the final decisions would be made in December 2019. With work proposed to begin late 2020.

Moved by Galardi, seconded by Appel, to approve the resolution as presented.

Whereas, The City park system does not have an accessible launch at Argo Livery; Whereas, The Argo and Gallup liveries are the largest in the state and part of the regional Huron River Water Trail; Whereas, The Park and Recreation Open Space Plan identifies an area of focus as renovating parks and facilities so that they comply with the Americans with Disabilities Act, while striving for Universal Accessibility. Whereas, The Argo livery site and restrooms are in need of renovation; Whereas, The Huron River Watershed Council has committed to fundraising for an accessible launch; and Whereas, Grants are available through the Michigan Department of

Natural Resources Grants Management to assist in funding improvements such as this project; RESOLVED, That the Park Advisory Commission recommends that City Council directs the City Administrator to apply to the Michigan Department of Natural Resources Grants Management for improving Universal Accessibility at Argo Livery.

J. Landefeld, Parks and Recreation Services Deputy Manager, explained that the current contract with Community Action Network (CAN), and the resolution is to approve a new five year agreement with a three year renewal option. He explained that there will be an increase in the requested funds, due to expanding services.

Commissioner R. Kraut inquired about an increase escalator for the agreement.

Landefeld explained that there will be a 3% increase per year.

Commissioner S. Borgsdorf inquired about the services provided by CAN.

Derek Miller, Executive Director of CAN, explained that the programming has quadrupled in some areas, and funding has stayed the same. He explained that the administrative costs for the organization is under 10% of the budget.

Councilmember Hayner inquired about funding for services provided in other areas or to other schools.

Miller explained that the funding for that programming is separate.

Moved by Borgsdorf, seconded by Kraut, that the resolution be

RESOLUTION TO RECOMMEND APPROVAL OF A FIVE -YEAR COLLABORATION AGREEMENT WITH COMMUNITY ACTION NETWORK FOR OPERATION OF BRYANT AND NORTHSIDE COMMUNITY CENTERS

Whereas, Community Action Network has been operating Bryant Community Center and the Northside Community Center since January, 2008;

Whereas, Community Action Network has provided excellent service for eleven years, developing an irreplaceable and indispensable knowledge of the communities it serves;

Whereas, The City desires to provide uninterrupted services undiminished in quality to these communities;

Whereas, Community Action Network has been identified as the 'best source' per City purchasing policy for continuing to provide these services;

Whereas, Community Action Network will continue to work in partnership with the City of Ann Arbor and other community agencies to provide community-directed outreach, social, and recreation services creating community centers that serve the immediate geographic neighborhoods for the Bryant Community Center and the Northside Community Center;

Whereas, This Partnership Agreement will continue to provide for City oversight of the Bryant Community Center and the Northside Community Center operation through regular reporting by Community Action Network to the City Parks and Recreation Services staff and quarterly administrative review; and

Whereas, Funds for implementation of the Partnership Agreement for FY2020 are included in the proposed FY2020 Parks and

Recreation Services General Fund budget; and

RESOLVED, That the Park Advisory Commission recommend approval of a five-year Partnership Agreement for services with Community Action Network in an amount of \$150,000.00 for FY2020 with an 3% percent compensation increase on each of the future years of the contract, contingent on Council's approval of funding for Bryant and Northside Community Centers.

C. Smith explained that the contract is for the Davey Tree Company to maintain the trees within the parks, primarily in pruning. He explained that in July 2018, funding for forestry maintenance within parks was moved to operate under the Parks and Recreation Department, and the remaining City of Ann Arbor forestry staff have a primary focus on right of way and street trees. Smith explained that through the contract, there is an opportunity to improve maintenance of neighborhood park trees and develop a pruning cycle.

S. Borgsdorf asked and C. Smith clarified that all tree removal would be at the direction of City Staff.

Commissioner M. Appel inquired about other bids.

C. Smith explained that two bids were received but the other was noncompliant.

M. Appel discussed movement of invasive species and standards within the contract to ensure best practices for operating.

L. London also discussed including standards within the contract.

Councilmember Hayner inquired about the price scale for moving trees to Leslie Science and Nature Center.

C. Smith explained that City staff would perform that work if necessary.

RESOLUTION TO RECOMMEND AWARDING A ONE-YEAR CONTRACT TO THE DAVEY TREE EXPERT COMPANY FOR PARK TREE CARE (\$450,000.00, BID NO. ITB-4558)

Whereas, Ann Arbor’s park and community forest is a defining and valued characteristic of the city that residents call “Tree Town,” making it a desirable place to live, work and play;

Whereas, Routine tree pruning is an important component of a sustainable forest management program; Whereas, Competitive bids for Park tree care were received by Purchasing on January 23, 2019;

Whereas, The Davey Tree Expert Company submitted a bid and possess the qualifications/experience in performing tree pruning needed as part of this contract;

Whereas, The Davey Tree Expert Company complies with the City non-discrimination and Living Wage Ordinances;

Whereas, The contract cost of \$450,000.00 is available in the approved FY19 Park Operations Millage Maintenance budget;

RESOLVED, That the Park Advisory Commission recommend approving a one-year contract in the amount of \$450,000.00 to The Davey Tree Expert Company for park tree pruning, removals, stump grinding, and emergency tree work in the parks and natural areas of the city with an option to extend the contract for up to two additional one-year periods under the same terms and conditions; and

RESOLVED, That the Park Advisory Commission recommend a contract contingency in the amount of \$45,000.00 (10%) be established to approve change orders to the contract with The Davey Tree Expert Company.
