1.     **14-0645**     Resolution to Approve a Request from Bravo Brio Restaurant Group, Inc. for a New Resort Class C License Located at 760 Briarwood Circle - d/b/a Bravo!

*Committee members expressed concerns about the status of both projects, BRAVO BRIO AND PF CHANG'S, noting that very little construction work had been completed at this time. Assistant City Attorney Mary Fales noted that the Michigan Liquor Control Commission will no longer accept a "conditional" approval. It was decided that additional plans and approvals would be necessary on the construction plans prior to the Committee making a recommendation. THE BUILDING OFFICIAL, RALPH WELTON, STATED HE NEEDED TO SEE ADDITIONAL MEP PLANS/DRAWINGS PRIOR TO MAKING HIS RECOMMENDATION. Committee members asked the City Attorney to speak with both applicants' attorney regarding their concerns. Committee asked staff to return to the committee when the project had progressed further in the building and construction phase.*
