Notice Is Hereby Given that on August 31, 2022, the Washtenaw County Water Resources Commissioner will hold a Day of Review of District Boundaries and a Day of Review of Apportionments from 9:00 a.m. until 5:00 p.m. at the Western County Service Center, 705 N. Zeeb Rd, 2nd floor, Ann Arbor, Michigan 48103.

The Water Resources Commissioner, engineers and other staff members will be available to assist individuals throughout the day and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

The **Day of Review of District Boundaries** is for the purpose of reviewing and revising the boundaries of the Drainage District and is an opportunity to review the Drainage District boundaries with the Water Resources Commissioner or a member of his staff. The **Day of Review of Apportionments** is an opportunity to review tentative apportionments with the Water Resources Commissioner or a member of his staff.

Comments on the apportionment of benefits may be submitted to the Water Resources Commissioner in writing before the date of the day of review or comments may be submitted in writing or verbally at the day of review. Comments submitted in advance must be received by the Water Resources Commissioner prior to the day of review to ensure consideration.

Proceedings conducted at this public meeting will be subject to the provisions of the Michigan Open Meetings Act. Information regarding this meeting may be obtained from the Washtenaw County Water Resources Commissioner's Office located at 705 N Zeeb Rd, Ann Arbor, MI 48103.

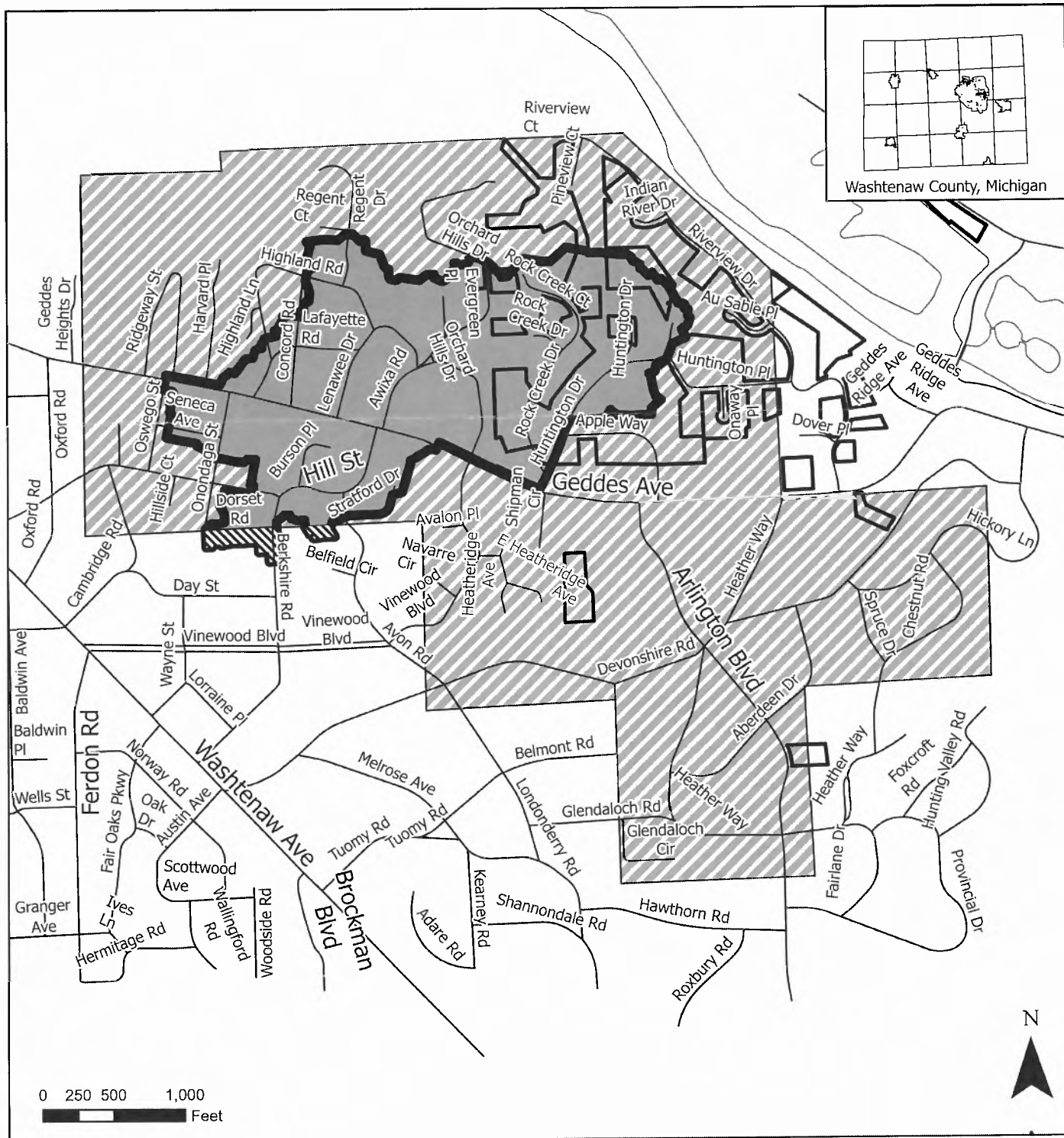

You may appeal the Water Resources Commissioner's decision to revise the district boundary to the Washtenaw County Circuit Court within ten (10) days, and you may also appeal the determination of apportionments to the Washtenaw County Probate Court within ten (10) days.


