Hi Andy,

As you may know, and as communicated to John Weiss, the application process for Coordinated Funding Program Operating was much more competitive than in previous cycles. We received 105 applications – which represents a 27% increase from last cycle. These requests totaled more than \$8.7 million, up from the \$6.85 million requested last cycle.

We have \$4.3 million to award (including Washtenaw County, City of Ann Arbor, United Way, and a small amount of Community Foundation funding), and thus were only able to fund fifty-eight of the 105 applications received. Every application we received demonstrated good – and important – work in the community, and that definitely holds true for the Neutral Zone. Unfortunately, along with forty-two other applications, we were not able to stretch the funds far enough to recommend an award to the Neutral Zone.

There are many factors/criteria that go into funding awards, most importantly a robust review and scoring process for all applications received. Applicants received the scoring matrix (aka the specific criteria against which they would be scored), as well as extensive orientation, prior to submitting

applications. This scoring matrix (attached) included twelve separate criteria. One applicant described this pre-distribution of the scoring matrix as “telling us how you’re going to grade us.” I would agree with this characterization, as our intent is always to create maximum transparency, objectivity, and predictability in what is an anxiety provoking process for all.

In the “School-aged Youth: Graduation” category to which the Neutral Zone applied, the lowest funded score received was a 76, and across all priorities and community-level outcome areas, the lowest funded score was a 73. The Neutral Zone received a total score of 69 points, putting it below the threshold we were able to fund. Participant income was one scored criterion in the process, but there were several other areas in which the reviewers did not award full points within Neutral Zone’s application.

We shared with John, and all of the other applicants, that we are scheduling times to meet in-person to do a “deep dive” in to the application, specific scoring, and to answer related questions.

I know you appreciate that this is a complex process with many variables and competing needs. We all want to fund every application, because every application represents critical work – and what is best about this community. The reality of increasing need and finite resources makes all of this more painful for everyone. I’m sorry about that, for all of us.

Please let me know if I can provide more detailed information, and I am happy to meet with anyone interested :). Also, as an FYI, I will also reach out to Sally prior to these recommendations going to the May 19th City Council meeting. For now, feel free to share what I have conveyed here as you see fit.

I received the bad news today that Coordinated Funding (a collaboration between County Human Services, United Way & Community Foundation) is recommending NO FUNDING, for our recent request for the S.C.O.R.E. Program. We had budgeted \$20,000 for coordinated funding in our FY 15 budget.

County Human Services had been funding drop-in & SCORE for years -- though it has been drastically cut from \$50,000 (6 years ago) to \$30,000, to \$10,000/yr for the past three years. I only received minimal feedback in a phone call today. I am about to request the scoring for our proposal along with reviewers comment -- to better understand why we didn't receive funding. As I understand it, the recommendations are going to the County Commissioners tonight, and I believe that will vote on the funding at a subsequent meeting. I am not sure what we can do to advocate at this point but I was reporting the news in case there anyone had some ideas. Even though I felt we submitted a strong proposal and made a great case for the need for SCORE/Drop-in, I wonder if Neutral Zone is perceived as being for privileged teens, and that a misconception still exists, as there had been in the past, that we don't serve many under-resourced teens.

1. The Clague project is working on the final design. If the easements and grading all works out the two large trees should be avoided.



2. No island is planned for the Green / Nixon intersection. Two islands are being built for the Thurston project (under construction) and the third island exists at Burbank. The two under construction are between Kilburn Park Circle and Whisperwood. When the Clague project is complete all three will be outfitted with rectangular rapid flashing beacons. Minor work will be done at the Green / Nixon intersection to upgrade signs and markings.

3. Unfortunately there is no good source right now. The City's website includes the map of conceptual improvements and it is out of date as some of the elements were deleted from the approved grant (i.e. sidewalk along Dhu Varren, raised intersection). The design plans for Clague are under development and I can share them when complete if that helps.

I believe we are looking at the same location on Green Road although your photo appears different. The current project is constructing 2 pedestrian crossing islands. One across Green at the Sugarbush (extension of Georgetown) and one approximately 400 feet west of Kilburn Park Cir. A rect. Rapid flashing beacon will be placed at the westerly island and one at the southern Burbank intersection (with existing island).

A coupe notes on the article, one the corner clearance work was dropped as the corner property was re-landscaped which eliminated the need for the work. Additionally no islands are planned for the Clague project but a flasher is proposed on the third island.

## **TEXT OF ARTICLE**

Safe Routes to School Program

- by David Bizot

The city is implementing several pedestrian improvements in or near the neighborhood this year. A 2010 "Safe Routes to Schools" grant (for Thurston Elementary) will fund the following improvements this spring:

-Upgraded crosswalk pavement markings at five intersections and upgrading advance school warning signs at 33 locations within the Thurston neighborhood.

-Constructing two new mid-block crosswalks on Green Road with pedestrian refuge islands north of Sugarbush Park, and a four- to three-lane conversion.

-Installing rectangular rapid-flashing beacons at two locations on Green Road (between the Burbank Drive intersections and at a new mid-block crosswalk north of

the Georgetown Boulevard sidewalk extension, after it passes Cedarbrook).

-Improving the sight distances at the intersection of Green Road at Gettysburg Road, installing advance flasher treatment, and separating the sidewalk from the road surface.

A separate, September 2012 Safe Routes grant (for Clague Middle School) is tentatively scheduled for construction in late summer/fall of 2013. This work will involve constructing new sidewalks on the east side of Nixon Road and an additional pedestrian island on Green Road.
