The Chair, Stephen Rapundalo, called the meeting to order at 3:00 p.m. in the 3rd Floor Conference Room of the Guy C. Larcom Jr. Municipal Building. Annual Liquor License Renewals

City Clerk Jacqueline Beaudry and Lyn Badalamenti of the City Clerk's Office reviewed with the committee the current status of the annual license renewals. Ms. Badalamenti noted that the City Treasurer had listed 11 licensees who were in arrears with personal property taxes. Deputy Treasurer Mike Pettigrew stated that the City Treasurer was recommending that those licensees be considered for non-renewal unless payment is made.

The committee directed the City Clerk to send the 11 licensees with personal property tax delinquencies a certified letter giving 30 days to make payment before further action by the committee would be considered.

Three businesses, Studio 4; The Fifth Quarter; and The Blue Leprechaun were identified as having possible nuisance cases pending in the City Attorney's Office or other Police or liquor control violations. It was determined that renewal letters would not be sent to these licensees at this time.

The committee authorized the Clerk's Office to send renewal letters to all other licensees not otherwise identified by the City Treasurer or the Police Department and who had no staff objections, except for those licensees who had not yet applied for annual renewal.

Review 2011 Calendar

The committee reviewed the schedule of meetings for 2011. It was decided to change the dates to the second Friday of each month at 3:00 p.m.
