Vice Chair Wendy Woods called the meeting to order at 7:05 pm.

City Planning Commission Meeting Minutes July 17, 2012

Moved by Adenekan, seconded by Clein, that the minutes be approved by the Commission and forwarded to the City Council. On a voice vote, the Chair declared the motion carried.

**6 REPORTS FROM CITY ADMINISTRATION, CITY COUNCIL, PLANNING MANAGER,
PLANNING COMMISSION OFFICERS AND COMMITTEES, WRITTEN COMMUNICATIONS
AND PETITIONS**

6-a City Council

Derezinski reported that at the previous Council meeting, the Council approved the Knight's Market rezoning and site plan. He said that there were comments about the floodplain that were addressed by the architect. He noted that the Speedway Site Plan was approved and that the rezonings of 922-926 Catherine Street and the public land parcel next to the Speedway site were approved at first reading.

Derezinski reported that Council approved the purchase of 2 lots of land through the Greenbelt program. He said that there was also much discussion about funding the contract for the Connector Study, which was voted down.

6-b Planning Manager

Rampson called the Commission's attention to the Meeting Calendar in their packets. She reported that staff had held their first ZORO office hours today, where the public were welcome to come and meet with staff and get their questions answered about the zoning reorganization draft. She said there would be another opportunity on September 11.

Rampson reported that there would be a Planning Commission Working Session immediately following today's meeting for a presentation and discussion on the PEV [Public Electric Vehicle] Ready Michigan Plan.

She said at the September 18 Planning Commission meeting, they would be starting the process to review and recommend to City Council the distribution of the 2012 Sustainability Framework, which will then be forwarded to neighboring jurisdictions for their review and comment.

Rampson reported that Kristin Baja, the project manager of the State Street Corridor Plan, would be making a presentation about the draft plan to the Commission on September 18.

6-c Planning Commission Officers and Committees

Bona reported the North Main Huron River Corridor Task Force has held three meetings, and the fourth meeting is next week. She asked if any Commissioners could substitute for her at next week's meeting. She encouraged those interested to go to the Planning web page for details of the meeting.

Pratt reported that the Master Plan Revisions Committee met earlier in the day and heard about the South State Corridor Plan, in addition to getting a sneak peak at the Sustainability Framework Plan. He said the committee is seeing a good fit between the two, moving beyond the traditional land use plan. He said he believes the result will be something pretty robust.

Westphal reported that the next Ordinance Revisions Committee meeting has been confirmed for September 17, at 5 pm. with the discussion focusing on the R4C/R2A area.

9-a 12-1168 Amendments to Chapter 61 (Signs and Outdoor Advertising) to dissolve the Sign Board of Appeals and shift its responsibilities to the Zoning Board of Appeals.

Rampson presented the staff report.

PUBLIC HEARING:

Noting no speakers, the Chair declared the public hearing closed.

Moved by Pratt, seconded by Derezinski, that the Ann Arbor City Planning Commission hereby recommends that the Mayor and City Council approve amendments to Chapter 61 (Signs and Outdoor Advertising), Section 5:517, to shift the responsibilities of the Sign Board of Appeals to the Zoning Board of Appeals.

COMMISSION DISCUSSION:

Bona asked about previously discussed amendments to the sign ordinance and if they would make it less restrictive or create more appeals.

Rampson said they do not anticipate a large increase in appeals due to the current sign ordinance, but that could change in the future as changes to the ordinance

occur.

Rampson explained that two years ago they had drafted changes to the sign ordinance and received public, but due to staff limitations the amendments hadn't gone beyond that. She said during the ZORO process, staff has been able to look at best practices in sign ordinance regulations and realized they need to start from the ground up to create a sign ordinance that the community feels that they want and is enforceable. She said that as a part of ZORO they have been able to make some minor changes to correct obvious mistakes.

Clein asked if the only change, with this proposed text amendment, would be that the applicant would be going before a different Board than earlier.

Rampson said that is correct; it would be the same Planning staff administering the process, adding that even fees would stay the same.

Mahler asked if there is a definition of 'practical difficulty and unnecessary hardship'.

Rampson said there is a substantial body of case law on practical difficulty and unnecessary hardships. She said when the text amendment is approved, the Zoning Board of Appeals would be receiving training on case law dealing with signage regulation as well as variances.
