ADMINISTRATOR'S COMMENTS

City Clerk Jacqueline Beaudry introduced Cresson Slotten, Systems Planning Manager, noting that the Board had previously requested the attendance of City staff involved with Transportation issues in the City, to discuss a possible future Transportation Commission that might include the oversight of Taxicabs, as well as other transportation systems in the City.

Regarding the Memorandum to Council on the proposed Transportation Commission, Ms. Beaudry, stated the Memo was included in the Clerk's Report to Council on July 21 and was received and filed, but there was not any additional discussion by the Council at that time.

Update on Dual Loading Zone Conversion

UNFINISHED BUSINESS

Revisions to Chapter 85 (Addition of Non-Metered Vehicles for Hire)

Assistant City Attorney Kristen Larcom was present to discuss the previously defeated Ordinance Amendment to Chapter 85, which would include the regulation of Non-Metered Vehicles for Hire.

Ms. Larcom noted that she can resubmit the ordinance to City Council, noting that as written it would cover TNCs.

The Board reviewed the draft and recommended a few changes, including 7:156(b) to include the words "for hire." There was discussion about this section requiring TNCs to comply with the State Limo Act, including requirements for insurance and commercial plates.

Officer Adkins requested that 7:156 (a) be changed to require the certificate of registration be displayed on the outside of the vehicle.

Chair Benson suggested that the ordinance also include regulation of pedicabs. Ms. Larcom replied that a separate pedicab ordinance might make more sense. It was decided to rewrite the ordinance to explicitly include pedicabs.

The Board also discussed the experience that Austin, Texas had with the regulation of TNCs. It was decided to invite the City Administrator to their next meeting to discuss this issue and the future role of the Board.

Ms. Beaudry stated that Mr. Slotten was in attendance to discuss next steps of the Board and their future, including the proposed Transportation Commission Ordinance. She noted that the Public Services Area had also reviewed a draft of a proposed Transportation Commission. Mr. Slotten stated at this point, he was in attendance to listen and learn. He noted that a concern of a Transportation Commission would be the availability of staff resources.

Commissioner Goeddel stated his interest in an expansion to a Transportation Commission is to take a more comprehensive robust approach to looking at transportation in the City, including how people move around the City, noting taxicabs are just one small piece of a transportation network that includes bicycles, busses, TNC, etc.

Chair Benson concurred, stating the Board was tasked with looking at their future role, but they have taken that a step further with this proposal. He encouraged City staff to provide feedback and guidance on next steps.
