Section 1.

The Central Student Government Assembly finds and declares all of the following:

WHEREAS,

The Central Student Government (CSG) is an elected body designed to advocate on behalf of the students of the University of Michigan; AND

WHEREAS,

Myefski Architects has proposed development in the area of South University Avenue that would include the demolition of the Galleria building and the termination of the leases of many businesses in the area, including local arcade, Pinball Pete's; AND

WHEREAS,

Pinball Pete's is, and has faithfully been, one of the few remaining arcades in Ann Arbor and Washtenaw County as a whole; AND

WHEREAS,

Pinball Pete's has been serving the Ann Arbor community for over 30 years¹; AND

WHEREAS,

Arcades are declining as an industry and are considered endangered as a medium of entertainment²; AND

WHEREAS,

Local residents have already organized in strong support of the preservation of Pinball Pete's³; AND

WHEREAS,

If the Ann Arbor Pinball Pete's were demolished, it would leave just one location of Pinball Pete's in East Lansing, Michigan.

Section 2.

THEREFORE it is, by the Students of the University of Michigan, through Central Student Government:

RESOLVED,

CSG strongly disapproves of Myefski Architects' proposal to demolish the Galleria building on South University Avenue;

AND FURTHER RESOLVED,

CSG encourages all parties to acknowledge the voices of the majority of students and Ann Arbor residents alike;

AND FURTHER RESOLVED,

CSG stands resolutely behind Ted Arnold, the staff of Pinball Pete's, and all other small business owners in Ann Arbor who would be impacted by this development;
