- 2. Payment terms: Billed directly by Travelers, in full.

- 4. Revised proposal offers extended term 3/1/2024 to 4/1/2025 (13 months) to align with board meetings.
- 5. Renewal timeline going forward: Hylant to provide new renewal information needed by first week of January and upon information being returned, will request to have the quote back for proposal March 1 in time for the March board meeting approval.
- 6. Premium is down from last year due to the reduction of entity assets.
- 7. Subjectivity for binding: Audited financials the by CPA required.
- 8. Major change in ownership or operations greater than 35% (was 50%): Run-off provisions- subject to additional pricing.

- 10. Coverage Extensions:
 - Crisis Management Coverage \$25,000 sublimit
 - Side A Personal Indemnification \$1M (shared limit)
- 11. Listed below are some of the areas where you are uninsured or potentially underinsured:
 - Limits consider limits sufficient to pay for defense of claims for all of the directors and
 officers, perhaps the company itself, with enough remaining to settle claims and satisfy
 judgments so that plaintiffs are not motivated to pursue individual director's and officer's
 personal assets. Additional side A, individual indemnification is \$1M.
 - In the event additional limits are considered, Travelers is only willing to offer the \$3M limit based on the asset size of the entity. An excess D&O policy would need to be arranged.
 - Activities outside of board duties
 - Shared additional defense limits (defense expenses erode the limits)
