Presentation of Plaque to Mayor Hieftje

*Leslie Staumbaugh, Chair of the Human Rights Commission, said that the Michigan Department of Civil Rights, US Attorney's Office, and a number of citizens groups, created the Michigan Alliance Against Hate Crimes (MAAHC). **1. Alan Haber - Compost Service and Library Lot (DS-2)**

*Alan Haber, 531 Third Street, expressed concern with the City's compost services being privatized and also expressed concern with the proposals for the Library Lot. Mr. Haber said that both projects seem to be connected to the common policy of privatizing what is public. He urged Council to consider the public in these decisions.*

**2. Jeannine Palms - City Compost (DS-2)**

*Jeannine Palms, 2650 East St., asked that Council postpone the approval of the changes proposed to the City Compost facility so that additional discussion could take place on the issue.*

**3. Lily Au - Avalon Housing (DS-16)**

*Lily Au, 682 Peninsula, expressed concern with Avalon Housing tearing down a 37-unit building and replacing it with a 32-unit building. She urged Council to do more for the homeless.*

**4. Libby Hunter - WeCare Contract and Heritage Row (DS-2)**

*Libby Hunter, 827 Bruce, serenaded Council to the tune of 'Santa Clause is Coming to Town' regarding opposition of the proposed WeCare contract at the Compost Center and the Heritage Row project.*

**5. Nicholas Nightwine - Compost Facility (DS-2)**

*Nicholas Nightwine, AFSCME Local 369 President, 2500 Packard, Suite 209, spoke in opposition of the privatization of the Compost Facility. He suggested adjusting the compost rates to the market rate in order to make the operation more profitable, in lieu of privatization. Mr. Nightwine suggested that if rates were adjusted, the City could revisit the issue again in a few years if necessary.*

**6. Thomas Partridge - Reforms needed to assure access to affordable housing and public transit. Amendments to zoning ordinances and public transit plans must be enacted. (B-1 and DS-1)**

*Thomas Partridge, 2120 Pauline, said that reforms are needed to assure access to affordable housing and public transit. Mr. Partridge said that amendments to zoning ordinances and public transit plans must be enacted.*

**7. Lou Glorie - Compost Facility (DS-2)**

*Lou Glorie, 827 Brooks St., spoke in opposition of the privatization of the Compost Facility, stating that that the rationale for privatization is not based on any real evidence.*

**8. Tim Hull - Bar Louie (File No. 10-1089)**

*Tim Hull, 1412 McIntyre, expressed concern with Bar Louie, a local liquor licensed business, discriminating against people who do not have a driver's license. Mr. Hull stated he has been denied a drink at Bar Louie because he possesses a State ID and not a Michigan driver's license.*

**9. Charles Ream - Medical Marijuana Business & Home Occupation Licenses (C-2)**

*Charles Ream, 1911 Packard, spoke in opposition of the proposed Medical Marijuana Business & Home Occupation Licenses Ordinance, stating that the home occupation license is illegal and the current draft mixes dispensaries in with cultivation facilities.*

**10. Odile Hugont-Haber - Library Lot**

*Odile Hugont-Haber, 531 Third St., expressed concern with the parking garage being constructed at the Library Lot. She encouraged Council to use the space as a public commons for the citizens of Ann Arbor.*

**COMMUNICATIONS FROM COUNCIL***COUNCILMEMBER HOHNKE*

*Councilmember Hohnke announced that two seats are available on the Environmental Commission. He encouraged those interested to apply and stated he would like to bring names forward at the next Council meeting.*

*COUNCILMEMBER RAPUNDALO*

*Councilmember Rapundalo informed the public that no decisions have been made from the last meeting regarding the Library Lot redevelopment. He stated a consultant was hired to look at the projects that were still being considered and to determine whether or not they were economically viable. The consultant was not hired to do a feasibility study. The committee will meet again to review the consultant's report and determine how best to move forward with a recommendation to Council.*

*The Huron Hills Golf Course RFP Review Committee met on December 3, 2010. There was a presentation by one of the bidders who qualified; the second bidder did not pass the staff technical review and was disqualified.*

*Councilmember Rapundalo thanked the City Administrator for his and staff efforts planning and putting together the Council Retreat on Saturday, December 4, 2010.*

*COUNCILMEMBER ANGLIN*

*Councilmember Anglin read a letter from a resident at 600 W. Huron Street, regarding the HAWK lights. The letter thanked the City for installing the lights at the intersection of W. Huron, Chapin, and Third Streets.*

*COUNCILMEMBER DEREZINSKI*

*Councilmember Derezinski said that another popular topic of discussion at the Council retreat was collaboration. Projects that show collaboration or consolidation with other communities are looked at more favorably at the State level for funding. Councilmember Derezinski cited the Washtenaw Avenue Corridor Study as a good example of many communities coming together on a project of mutual interest.*

*MAYOR HIEFTJE*

*Mayor Hieftje said that the DDA received a report from the Downtown Citizens Advisory Council. They were very happy with the work at West Park. Mayor Hieftje stated the Downtown Citizens Advisory Council made a suggestion to rename West Park as Central Park West.*

*Mayor Hieftje also announced that a new park opened downtown next to the new U of M residence hall between Washington and Huron.*

**COMMUNICATIONS FROM THE CITY ADMINISTRATOR****TAX BILLS**

*City Administrator Roger Fraser reported that winter tax bills have gone out in the mail to property owners. Taxes are due on the 31st of December; however, due to the holiday calendar this year, the City will be closed on December 31. As a consequence of the holiday schedule, the City will be accepting payments postmarked or received in-person on January 3, 2011 as received on time. Payments are accepted online, by mail, or in person at the City's Customer Service Center.*

*Mr. Fraser noted that the City is expecting about a 4 percent reduction in property tax revenue this year, largely due to the Pfizer property finally coming off the tax rolls.*

**COMPOST PICKUPS**

*Mr. Fraser reported that curbside compost collection will be provided through Friday, December 10, 2010. Compost collection will resume again on April 4, 2011. Mr. Fraser thanked residents for their cooperation during this year's transition with the Fall leaf pick-up program.*

**PACE PROGRAM**

*The Michigan State Legislature joined 25 other states in passing legislation for the PACE Program. The program is a property access clean energy project that allows for special assessment districts to be created for energy improvements in homes. The City expects to be a leader with PACE as projects move forward.*

**PHOSPHOROUS LIMITS**

*Mr. Fraser informed Council that the Michigan State Legislature passed phosphorous limits across the state. The Huron River Watershed Council and Michigan Environmental Council were significant in helping to make this a reality.*

**MICHIGAN BY RAIL PUBLIC FORUM**

*The Michigan by Rail public forum will be held on December 9, 2010 from 6-8 p.m. at Washtenaw Community College. Sponsors for the event include the Michigan Environmental Council, the Michigan Association of Railroad Passengers and the Michigan Municipal League. The City will also be a co-host to this important event.*

**PLANNING AND DEVELOPMENT SERVICES RELOCATED**

*Planning and Development Services have been moved temporarily to the 5th floor of City Hall. Community Services Administration and the Parks and Recreation Manager and Assistant Manager have been moved to the City Center Building on the 7th floor.*

**COUNCIL CHAMBER MEETINGS RELOCATION**

*Mr. Fraser reminded Council that Council meetings for January and February 2011 will be held in the County Commissioners' Board Room located at 200 N. Main. There will be no meetings in Council Chambers during the months of January and February 2011.*

**MILLER STREET RECONSTRUCTION**

*Mr. Fraser announced that the Miller Street Reconstruction Project was completed on November 21, 2010.*

**ARBOR OAKS WATERMAIN REPLACEMENT PROJECT**

*The Arbor Oaks Watermain Replace Project has been completed. The project includes resurfacing of Champagne Drive, Hemlock Drive and most of the courts in the area. This work will begin in March 2011. A public engagement on the project is planned for December 16, 2010 at the Bryant Community Center.*

**WASHTENAW AVENUE NON-MOTORIZED PATH**

*The Washtenaw Avenue Non-Motorized path project will begin in March 2011. The low bidder on the project was actually \$100,000.00 less than the engineer's estimate, which is a continuing reflection of what's happening with the economy.*

**COUNCIL RETREAT UPDATE**

*Mr. Fraser updated the public about the Council retreat. He stated that as staff planned the session, they chose to focus on defining a sustainable set of City services. Mr. Fraser stated the City is anticipating an additional \$2.5 million dollar reduction in available resources for the year 2012 and again in 2013. He stated personnel cuts at this point would mean cuts in services provided to the public.*

*Mr. Fraser noted that Ann Arbor.com published a story regarding the retreat and focused on the discussion regarding the Fire Services. Mr. Fraser stated that despite how the article presented the issue, this was only the beginning of a discussion on how to address the Safety Services budget, which represents more than half of the total General Fund budget. A paid on-call system is just one possibility that Council indicated they would be willing to further study as they prepare the budget.*

*A second meeting is planned to continue this discussion on January 8, 2011, again at the Wheeler Center. All materials from the Work Sessions and retreat are available on the City website, [www.a2gov.org](http://www.a2gov.org).*

**CHRISTMAS TREES**

*Sue McCormick, Public Services Area Administrator, said that Christmas trees would no longer be picked up curbside. The options for Christmas tree removal is available online for interested residents.*

*A public hearing was conducted on the proposed amendment to Chapter 55, Rezoning of 6 Park Properties (Arbor Oaks Park, Berkshire Creek Nature Area, Bluffs Nature Area, Glacier Highlands Park, Mallets Creek Nature Area, Scheffler Park) from AG (Agriculture District), R1B and R1C (Single-Family Dwelling Districts), R4A and R4B (Multiple-Family Dwelling Districts), O (Office District), C1 (Local Business District) to PL (Public Land District) (Ordinance No. ORD-10-38). Notice of public hearing was published November 18, 2010.*

*Ethel Potts, 1014 Elder Blvd., expressed concern with zoning the properties as PL, as this zoning has not protected parks in the past.*

*Thomas Partridge, Pauline Blvd., spoke in support of the ordinance but said that it should be amended to include affordable housing.*

*Kathy Boris, 1726 Charlton, expressed concerned with the PL zoning allowing the property to be used for something other than recreation and open space.*

*Dorothy Nordness, 114 Eighth St., expressed concern about the rezoning, stating she did not want parkland repurposed for other uses.*

*Rita Mitchell, 621 Fifth St., expressed concern regarding the flexibility under the PL zoning. She stated she wanted to preserve existing parkland.*

*There being no further comment, the Mayor declared the hearing closed.*

**COMMUNICATIONS FROM COUNCIL***MAYOR HIEFTJE*

*Mayor Hieftje clarified that the rezoning of parkland to PL (Public Land) was for the purpose of protecting the parks. He noted that many of these properties were previously zoned office, residential or industrial. The Mayor noted that under these zonings, the Charter Amendment might not protect the properties as they are not properly classified as parkland. Mayor Hieftje stated that these rezonings are a result of Councilmember Anglin's concern that not all of the properties everyone considers to be parks actually appeared in the PROS Plan or were zoned public land and he specifically requested the city staff work to get all of the parks correctly zoned. For about two years that is what City staff has been doing. So we have had a series of these coming to us in order to better protect these park lands and the Planning Commission has been in full agreement throughout.*

*COUNCILMEMBER ANGLIN*

*Councilmember Anglin said that every five years the City comes forward with a PROS Plan (Parks and Recreation and Open Space Plan). The PL designations that Council is considering tonight are in that PROS Plan. Councilmember Anglin stated that even though these parks are zoned PL, they still have to be included in the PROS Plan. Each park has to be identified and numbered. Councilmember Anglin stated he does have some reservations about the inclusiveness of the PL zoning and stated that is why inclusion in the PROS plan is so important for protecting parks.*

*Mr. Anglin asked that the people who spoke at the Public Hearing regarding the rezoning of the parks mail Council copies of their statements if possible.*
