Executive Committee meets December 12

SEMCOG's Executive Committee will meet at 1 p.m. on Friday, December 12, 2008, in SEMCOG's downtown Detroit office. Action items to be considered by the committee are as follows:

- Endorsing the federal and state legislative policy platform for 2009-2010. These issues will guide discussions with Southeast Michigan's congressional delegation and with our state senators and representatives;
- Approving an amendment to the FY 2008-2011
 Transportation Improvement Program to add 98 projects
 and delete nine projects. The net funding change for this
 amendment is \$259.9 million, representing an increase of
 \$195.3 million in federal, \$57.2 million in state, and \$7.4
 million in local funding; and
- Approving a 2008-2009 SEMCOG Work Program budget amendment that adds \$33,000 for a new Local Roads Asset Management project.

Results of SEMCOG member survey indicate strong satisfaction

According to SEMCOG's recently completed member satisfaction survey, members are very satisfied with the services they receive from SEMCOG. According to the 2008 Cobalt Citizen Satisfaction Index for Michigan, local governments deliver an average satisfaction level of 52 on the 1-100 scale. SEMCOG delivers an 80, with a stronger rating by local government staff, who tend to be the heaviest users. While satisfaction is strong, these are the areas in which SEMCOG will focus improvement:

- Access and location of training,
- Web site ease of use,
- Closer tailoring of programs and services to audience segment, and
- Enhance member services.

Members also indicated a significant need for case studies, benchmarking/best practices (including outside of Southeast Michigan), regional trends, and information to help stretch budgets.

The 2008 SEMCOG Member Satisfaction Survey was conducted by Cobalt Community Research (Lansing, MI). It was mailed to SEMCOG members in September and October 2008. Approximately 1,531 surveys were distribute

Key legislation was recently introduced in the Michigan House of Representatives to increase funding transportation needs. The legislation has a broad range of supporters and is poised to move in the lame duck session, but will not pass unless legislators hear from local officials. SEMCOG urges safe and sober holiday driving

With more people expected to travel on America's highways during the holiday season, SEMCOG urges everyone to enjoy the holidays, but know the facts — alcohol is a significant factor in holiday deaths.

In Southeast Michigan, alcohol was involved in 31 percent of all fatal crashes in 2007. Alcohol was a factor in 122 deaths and over 2,600 injuries in 2007. Search SEMCOG's traffic crash
