Good Afternoon, Kathy -

I hope this message finds you well. It has been a few years since I last reached out – then as President of the Jim Toy Community Center – after connecting with your son through social media. Since then, I have been elected to the Ann Arbor City Council and am currently the only openly-gay councilmember. I know I owe this considerable honor, in part, to your trailblazing campaign and election nearly five decades ago.

I'm reaching out today – as I did previously – because I believe that Ann Arbor should be doing more to honor your legacy. I have had some discussion with our City Clerk about developing a historic plaque for the Council Chambers themselves; however, as Ann Arbor approaches our Bicentennial in 2024 – conveniently the 50<sup>th</sup> Anniversary of your own election – we have been approached with a couple opportunities to honor you in a much bigger way.

An organization called <u>Statues for Equality</u> has approached Mayor Christopher Taylor about identifying a historic figure for whom we could commission and dedicate a statue. We quickly came to agreement that you would be an ideal person for this recognition –

along with a potential State of Michigan Historical Marker – to celebrate both our city's Bicentennial and the coinciding anniversary of your election. We believe there would be considerable community support for such a project – as well as interest from national LGBTQ organizations – like HRC and Victory Fund/Institute.

Before proceeding, however, we hoped connect with you to hear your thoughts and hopefully secure your blessing to move forward. I would be happy to answer any questions you may have by email – or would love to find a time to chat on the phone (my number is a second of the phone).

I've also included Mayor Taylor on this email, should he wish to provide any additional context, as well as our City Clerk and City Administrator, who have been involved in some of these discussions.

Thanks for your email. I'm one of your Ward 4 CMs as well as the Council liaison to the Transportation Commission. I completely agree with you regarding paint only along roads with these speeds. I'm a bike commuter myself and my experience of Stadium is exactly as you describe.

Transportation Plan, we are creating an All Ages All Abilities network throughout the city that calls for different treatments depending on vehicle volume and speeds and we have begun implementing it. One obstacle that I hope will be addressed soon is arrival of a mini street sweeper (estimates are in September) that we have been waiting on to install vertical delineators in buffered bike lanes. We have the delineators ready to go, but staff has stressed the importance of waiting until we can properly maintain these lanes before we install the delineators.

We have (or soon will have) 11 miles of buffered bike lanes outside of downtown ready for this treatment (goal is 5 new miles per year). Here are some examples -we removed vehicle lanes from South Main St and added buffered bike lanes. Delineators will be added (https://www.mlive.com/news/ann-arbor/2022/01/ann-arbor-continuing-road-diet-experiment-on-south-main-

## street.html)

- -The <u>State and Hill Street improvement project</u> will narrow vehicle lanes and on street parking to install buffered bike lanes with vertical delineators
- -Packard street from State to Main: has the painted buffered bike lanes and is waiting on delineators.
- -<u>Platt road improvement project</u>: in progress. We are removing a vehicle lane and adding in buffered bike lanes with vertical delineators

On a related note, the City is also about to embark on a speed management program along major roads, because speeds are a major factor in serious injuries and death:

I really appreciate you sharing your feedback and will continue to push for us to slow vehicle speeds and provide safe, comfortable infrastructure for people walking and biking.

As a person who bikes around the city, I am tired of being inches away from several ton vehicles traveling at 35, 40, 45 miles per hour, protected by nothing more than a helmet and a line of paint. I am tired of being placed in the blind spots of cars and forced to merge into the car lane without warning. I am tired of my life depending on everyone on the road behaving perfectly all the time.

Please stop adding unprotected, painted-on bicycle gutter lanes. It is my belief that these lanes are actively worse than nothing because they create the illusion of

safety. Instead, please add proper, protected bicycle infrastructure. Ideally, remove at least one car lane in the process. If done right, this would also greatly reduce traffic, prevent the formation of potholes, reduce pollution, and make the experience more pleasant for everyone on the road (including the car drivers). The protected lanes that have recently been added to some streets downtown are a good start, but I would also like to see similar infrastructure added to Washtenaw, Stadium, Packard, and other large stroads (more on stroads here: <a href="https://www.youtube.com/watch?v=ORzNZUeUHAM">https://www.youtube.com/watch?v=ORzNZUeUHAM</a>).

Good evening. I am a Ward 1 resident with some questions about city policy. There is a growing number of people living in tents along the Huron River in between the FullerRoad overpass and the train tracks. I'm not sure if this is within Fuller Park or Mitchell Field or even if it is city land or UM land.

Last week I counted at least four tents and saw several people around a pretty good-sized campfire. I see this as a significant risk, especially with a fire that has the potential to spread very quickly.

I called AAPD to see how they handle situations like this and was told more or less that they know about this area and there isn't much they are able to do unless a crime is committed or the fire actually gets out of control. To me, that seems a little late.

The police told me there are many places like this in the city, where people are encouraged to live.

- 1. Does the city have a set policy or plan for this situation throughout the city?
- 2. Is the city allowing and/or encouraging people to live in tents on public land?
- 3. Do you know this area and know who owns it?
- 4. How is the council responding to claims that the increase in the homeless population is responsible for the massive increase in crime?

Not to mention, some of us on the circuit have had four outages in the past five months - this just does not feel acceptable.

Greetings Mayor Taylor and members of the city council,

My family lives on Olden Rd. in the Upper Water HIll area of Ann Arbor. As I'm sure you're aware, there was another power outage last week that caused considerable damage to expensive appliances and electronics in the homes of many of my neighbors. We are fortunate (but still incredibly disappointed) to have only lost our (new) hot tub in the power surge/outage.

I've lived in many areas of the country in my lifetime and have never experienced this level of insecurity when it comes to energy. Considering the amount we pay in taxes to live in this area, I'm frankly shocked that we don't have more reliable service. The Summer of 2021, we were out of power for a week. This past March in 20 degree temperatures, we were out of power for nearly a week. On May 19th, my husband and I were watching a television show and there was a frightening explosion very close to our house that lit up the sky for seconds. It was terrifying. We had no idea what had happened. My body involuntarily shook for 15 minutes while we sat in darkness. Once again, this past week we awoke to a loud explosion that was followed by a second explosion. Power was out until the following afternoon. What on Earth is going on?? At the very least, an explanation is in order. Or some kind of respectful response to the community acknowledging how these terrifying explosions and outages might be affecting the community and what is being done about it -- if anything.

We are a close knit community here in Upper Water Hill. I've been talking with many neighbors who have lost several thousand dollars worth of appliances. Yes, home insurance is providing reimbursement for the damaged appliances -- but not without raising premiums. Is DTE not liable for our losses? Are these explosions dangerous? What can be done??
