### 2. **Karen Paul – Gerald Alcock Company**

*Karen Paul, of Gerald Alcock & Company, gave an overview of the estate the real estate market. She said that the market is changing almost daily. Within the submarket of Washtenaw County, land transfers have slowed significantly since the last quarter of 2008. The fallout of Wall Street and the automotive market have strangulated the credit markets and willing buyers and we are now relying more heavily on older data.*

*There are no super deals coming soon, so they have to look at other industries to gage the evaluation. She said that is a stronger market for purchases would be on the west side. A lot of talented developers have moved into Superior and Ypsilanti Townships.*

*She concluded by stating that her perception of the market is that the area would recover eventually. Ms. Paul then answered questions from the commission.*
