Thank you for your business! IntegrYS Energy Services is pleased to be City Clerk, Ann Arbor's electricity supplier.

We are writing with information regarding IntegrYS Energy's compliance with Michigan's Clean, Renewable and Efficient Energy Act, signed into law last October by Governor Jennifer Granholm.

This legislation includes a Renewable Portfolio Standard ("RPS"), which requires that starting in 2012 a portion of all electricity sold to end-use customers in Michigan (regardless of supplier) must come from renewable sources. To comply with this legislation and the related order from the Michigan Public Service Commission (MPSC), IntegrYS Energy filed a renewable energy plan with the MPSC on February 25, 2009. As our customer, you will have the opportunity to comment on the RPS plan. Attached please find your Notice of Opportunity to Comment, which includes detailed instructions about how you can review the RPS plan and file comments. Please note that anyone wishing to file comments must do so by March 27, 2009.

The MPSC will review the renewable energy plan together with any filed comments and provide a response by April 27, 2009 indicating any revisions that should be made. If needed, IntegrYS Energy will file a revised RPS plan on or before May 12, 2009, and a final Order will be issued on or before May 27, 2009.

On December 4, 2008, the Michigan Public Service Commission (Commission) ordered Integrys Energy Services, Inc. & Quest Energy, LLC to file a renewable energy plan on or before February 25, 2009 to comply with the "Clean, Renewable and Efficient Energy Act" (2008 PA 295, MCL 460.1001, et seq.) in Case No. U-15800.

The Commission will review the renewable energy plan together with any filed comments and provide a response by April 27, 2009 indicating any revisions that should be made. If the Commission suggests revisions, Integrys Energy Services, Inc. & Quest

Energy, LLC will file a revised RPS plan on or before May 12, 2009. A Commission order will be issued on or before May 27, 2009.

Any proposed Renewable Energy Plan Charges may not exceed \$3 per meter per month for residential customers, \$16.58 per meter per month commercial secondary customers or \$187.50 per meter per month for commercial primary or industrial customers.
