Dear Governor Snyder:

This letter serves as notice that on September 6, 2016 the Bay City Commission passed a resolution strongly objecting to your veto of Senate Bill 557 and is urging a Legislative override in order to alleviate the financial burden to local communities and restore some measure of equity to the forty-five municipalities that fall under the current legislation.

Your veto will cost the City's taxpayers over \$2,001,000 in State Road funding to rebuild an MDOT bridge which serves a region much larger than the City. This equates to almost one year of State Road funds and it will result in one full year that the City will not be able to repair our City streets.

Of Commission as a Whole:

Michigan Whereas. the Department of Transportation will totally reconstruct/rebuild the Lafayette M84/ M13 at an estimated cost of \$43,428,829; and

Whereas, currently the City of Bay City's Act 51 total revenue is approximately \$2,300,000 per year, so this match will utilize 43.4% of our allotted budget; and

Whereas, as a direct result of current state law the city will be required to reimburse the Michigan Department of Transportation 5% of the project cost and is estimated to be

approximately \$1,000,000; and Whereas, the "loss" of 43.4% would impact our routine maintenance and winter maintenance activities for approximately two years and along with severely limiting our repayement efforts of local streets; and

the has Whereas, repeatedly voiced opposition MDOT's proposed change to the project phasing as well as the use of Act 51 funding formula for road projects with regional, national, and even international significance and impact; and

Whereas, the City has provided supportive testimony to both the Senate House Committees

Transportation both of which unanimously recommended approval of Senate Bill 557; and

Whereas, the Michigan Senate and House unanimously approved Senate Bill 557 on May 31, 2016, and June 9, 2016, respectively; and

Whereas, on July 1, 2016, while admitting that the Act 51 requirement for local cost sharing places a hardship on those communities required to use most, if not all, of their available local road funding for interstate highway projects, Governor Snyder vetoed Senate Bill 557 thereby keeping the local match contributions.

Now Therefore Be It Resolved that the Bay City City Commission strongly objects to the Governor's veto and urges a legislative override this year in order to alleviate the financial burden to local communities and restore some measure of equity to state highway funding in Michigan.

Be It Further Resolved that the City of Bay City strongly recommends that the State Senate and the House of Representatives take immediate action to override the Governor's veto of Senate Bill 557 to restore equity to the forty-five municipalities that fall under the current legislation

Be it Further Resolved that the City Clerk provide a copy of this Resolution to U.S. Senators Stabenow and Peters, U.S. Representative Kildee, State Senator Green, State House Representative Brunner, Governor Snyder, Michigan Municipal League, and the following forty-four impacted Cities: Detroit, Grand Rapids, Warren, Sterling Heights, Lansing, Ann Arbor, Flint, Madison Heights, Dearborn, Livonia, Westland, Troy, Farmington Hills, Kalamazoo, Wyoming, Southfield, Rochester Hills, Taylor, St. Clair Shores, Pontiac, Dearborn Heights, Shores, Pontiac, Royal Oak, Novi, Battle Creek, Saginaw, Kentwood, East Lansing, Roseville, Portage, Midland, Muskegon, Jackson, 1 incoln Park, Eastpointe, Port Huron, Southgate, Burton, Oak Park, Allen Park, Garden City, Mount Pleasant, Wyandotte, and Inkster.
