

ANN ARBOR 2015 DECEMBER BOARD OF REVIEW MEETING

The Ann Arbor Board of Review met on December 13, 2016 to make corrections to the 2013, 2014, 2015 and 2016 Assessment and Taxable Value Rolls. The Board also reviewed Affidavits for Principal Residence Exemption which were submitted late or by new owners for the 2013 through 2016 tax years.

The following corrections were made on the 2013 through 2016 Assessment and Taxable Value Rolls, respectively.

The Board of Review Members reviewed and approved the changes to the 2013 through 2016 Real Property and to the 2015 and 2016 Personal Property Assessment and Taxable Value Rolls. Additionally, they have reviewed and approved Principal Residence Exemption changes for 2013 through 2016. They also have reviewed and approved the changes to the 2016 Real Property Roll for Poverty and Veteran Exemptions.


