PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

At 8:45 p.m., Mayor Taylor called for Public Comment:

Barbara Perkins, former member of the Ann Arbor Airport Advisory Commission, spoke about the presentation from the Ann Arbor Airport, and stated she has fought against airport expansion for years.

Andrew McGill, representing a grassroots citizens group in opposition to the airport expansion, spoke in opposition to airport expansion and expressed concern about safety issues.

Kathy Wonderlick, representing grassroots citizens group in opposition to the airport expansion, spoke in opposition to airport expansion.

Jim Vincent, resident of Pittsfield Township, and retired UM professor, spoke in opposition to the airport expansion proposal and asked Council to study the noise more carefully.

Saul Costell, pilot, expressed concerns about how the FAA conducts noise studies. He spoke in opposition to the proposed runway expansion.

Michael Yi, a Pittsfield Township trustee from Stonebridge neighborhood, spoke in opposition to a runway expansion of the Ann Arbor airport, including the ability for larger jets to use the airport. He questioned the accuracy of the economic impact assessment.
