Hi Christopher,

It seemed too technical to fit into my 3 minutes to City Council tonight, but I'd like to pursue the loophole that we discovered in the noise prohibitions.

Chapter 119, Section 9:363(5) Specific prohibitions (5) says "Construction, repair, remodeling, demolition, drilling or excavation work at any time on Sunday and between 8:00 p.m. and 7:00 a.m. Monday - Saturday, except as permitted by section 9:365(2)." It does not say that holidays shall be treated as Sundays, so we had cookout plans that were thwarted on Memorial Day and the noise was too loud to be able to garden on July 4.

What's the next step in getting this regulation amended to mention holidays?

Thank you for all your help in getting the various City officials to respond. Without your advocacy, the past two years would have been far worse.
