# **Presentation by Susan Lackey**

Susan Lackey, Executive Director of the Legacy Land Conservancy, addressed the commission regarding the Natural Area Farmland and Protection Program. She updated the commission on where they are and how the program ties into the county millage and greenbelt program. The Legacy Land Conservancy, who is under contract with Washtenaw County, manages the protection of Natural Area Farmland and Protection Program. She said that they would be looking at programs like the greenbelt to help leverage dollars to protect farmland in the future.

Ms. Lackey gave an overview of their first round of applicants. She said that 57 farms have applied which totals approximately 5600 acres that could potentially be protected. They have prioritized properties in Webster, Salem, Lima, Superior, York and Dexter. Their next steps are to notify other townships that they are considering for FRPP rights. Ms. Lackey then answered questions from the Commission.

# Archer Christian introduction

Commissioner Garfield, introduced Archer Christian of the Ecology Center to the commission. Ms. Christian has back ground in agricultural organization and is interested in becoming a member of the Greenbelt Advisory Commission. Ms. Christian said this was a long standing passion of hers and would enjoy the opportunity to serve on the commission.
