- 1. Thomas Partridge - Vote for Tom Partridge write-in candidate for Ann Arbor 5th Ward. Reform Council Rules and DDA. Build affordable housing throughout the City. End illegal discrimination and corruption in Ann Arbor City Government.**

*Thomas Partridge, Ann Arbor resident, asked that citizens vote for him as a write-in candidate for the 5th Ward City Council Member. He also addressed Council regarding the Council Rules, the restructuring of the DDA, the need for more affordable housing and he called for an end to discrimination.*

**2. Mike Shriberg - Motion to Reconsider Fossil Fuel Resolution (DC-4)**

*Mike Shriberg, 1473 Pine Valley Blvd., member of the Energy Commission, addressed Council regarding the motion to reconsider the vote that defeated the Resolution to Urge the City Pension System to Divest from Top 200 Publicly Traded Fossil Fuel Companies. He stressed that the passage of this resolution would not harm the Pension system.*

**3. Wayne Appleyard - Motion to Reconsider Fossil Fuel Resolution (DC-4)**

*Wayne Appleyard, 5750 Prospect Hill, Chair of Ann Arbor Energy Commission, addressed Council regarding the motion to reconsider the vote that defeated the Resolution to Urge the City Pension System to Divest from Top 200 Publicly Traded Fossil Fuel Companies. He expressed the importance of the resolution, but noted that it is non-binding and would not reduce the viability of the Pension's investment funds.*

**4. Dina Kurz - Motion to Reconsider Fossil Fuel Resolution (DC-4)**

*Dina Kurz, 2731 Provincetown Ct., member of the Energy Commission, spoke to Council regarding the urgency behind the motion to reconsider the vote that defeated the Resolution to Urge the City Pension System to Divest from Top 200 Publicly Traded Fossil Fuel Companies. She said that passing this resolution would have little to no impact on Pension Fund members.*

**5. Jeff Hayner - Non-Motorized Trans. Crosswalk Ordinance**

*Jeff Hayner, 1807 Pontiac Tr., addressed Council regarding the City's Crosswalk Ordinance. He encouraged Council to model the City's crosswalk ordinance after State law.*

**6. Dave Marvin - Motion to Reconsider Fossil Fuel Resolution (DC-4)**

*Dave Marvin, 111 N. Ashley St. #7, addressed Council regarding the motion to reconsider the vote that defeated the Resolution to Urge the City Pension System to Divest from Top 200 Publicly Traded Fossil Fuel Companies. He urged Council to pass the resolution, which is complimentary to Ann Arbor's own Climate Action Plan. He also spoke about the need for change in Energy policies.*

**7. Laura Hobbs - Motion to Reconsider Fossil Fuel Resolution (DC-4)**

*Laura Hobbs, 1346 Geddes Ave., addressed Council regarding the motion to reconsider the vote that defeated the Resolution to Urge the City Pension System to Divest from Top 200 Publicly Traded Fossil Fuel Companies. She urged Council to have Ann Arbor stand with other cities in support of fossil fuel divestment. She said the passage of this resolution will show that Ann Arbor recognizes the harmful effects of climate change.*

**8. David Blanchard - Communication from Housing and Human Services Advisory Board**

*David Blanchard, 1230 Broadway St., addressed Council regarding a communication from the Housing and Human Services Advisory Board regarding the DDA Ordinance revisions. He urged Council to continue to protect priorities like affordable housing and to hold affordable housing harmless in any changes to DDA funding.*

**9. Larry Junck - Motion to Reconsider Fossil Fuel Resolution (DC-4)**

*Larry Junck, 2128 Wallingford, spoke in support of the proposed motion to reconsider the vote that defeated the Resolution to Urge the City Pension System to Divest from Top 200 Publicly Traded Fossil Fuel Companies. He said that this is a sound investment decision and it fits well with Ann Arbor's Climate Action Plan.*

**10. Kathy Griswold - Pedestrian Crosswalk Ordinance**

*Kathy Griswold, 3565 Fox Hunt Dr., addressed Council regarding the Pedestrian Crosswalk Ordinance. She urged Council to repeal this ordinance, noting her concerns about pedestrian safety.*

*Councilmember Briere updated Council on the Planning Commission's review of the D1 Zoning. A final workshop/public meeting is scheduled for September 19, 2013 at the Workantile Exchange on Main Street at 7 p.m., she stated. This is an opportunity for the public to look at the recommendations from the consultant, and to talk about the effects and benefits and possible detriments of premiums, before a final recommendation goes to the Planning Commission and Planning Commission makes a recommendation to Council.*

**U of M Street Closures Preliminary Report - Police Chief John Seto***UPDATE ON CLOSURE OF STREETS FOR U OF M FOOTBALL GAMES*

*Police Chief John Seto updated Council on the Main Street closures during the first three UM home football games. He stated that a more in-depth report would be provided at the October 7 City Council meeting following the upcoming September 24 neighborhood meeting at Pioneer High School scheduled to gather comments and feedback from the residents in the surrounding neighborhoods. Chief Seto stated the focus has been on the impacts to traffic patterns and parking around the stadium.*

*Public Services Area Administrator Craig Hupy addressed Council regarding the street closures and the detour routes for traffic. He stated the detour has been tweaked with each game, including the timing of the light signals on major roads. Mr. Hupy stated there was a bottleneck at the light at Maple and Stadium and that has been corrected.*

*Councilmember Higgins suggested that Public Services also look at the light at Maple and Scio Church Roads.*

*Chief Seto and Mr. Hupy were available to answer any questions of Council.*
