CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:04 p.m. in the Guy C. Larcom Jr., Municipal Building, 2nd Floor Council Chambers, 100 N. Fifth Avenue.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

Mayor Hieftje led Council in the recitation of the Pledge of Allegiance.

INT INTRODUCTIONS

INT-1 10-0148 Resolution to Approve a Pre-Paid Parking Rate During Special Events/Busy Evening Parking

Susan Pollay, Executive Director of the Downtown Development Authority, shared information regarding the DDA and its parking system. The DDA has created a new \$5.00 pre-pay parking rate. The rate is being created to allow pre-payment for special events and busy evening parking. The rate would allow patrons to pay when entering the structure, so that on their way out, the gate arm would automatically lift as they leave. It enables the DDA to address some operational issues at some of their facilities. In automated lots like the Library Lot and the lot at 415 W. Washington, patrons are aware that late at night it is possible to crash through the gate arm without stopping and paying. The new rate is also an attempt to try and alleviate some of the crowds that have caused fights and disturbances in parking structures after large events. This would help the Police Department greatly.

INT-2 10-0176 Introduction of Planning & Development Unit Personnel - Roger Fraser

City Administrator Roger Fraser introduced new personnel in the Planning and Development Services Unit. Wendy Rampson has agreed to take on the responsibilities of Land Use and Planning Manager in a permanent role, having been filling in as the interim Planning and Development Manager. Ralph Welton will assume the responsibilities of Chief Development Officer/Plan Reviewer and Lisha Turner-Tolbert is the new Planning and Development Services Projects and Programs Manager.

1. Thomas Partridge - Giving priority to funding and building affordable housing in Ann Arbor and Washtenaw County

Thomas Partridge, 4220 Eyrie Dr., addressed Council regarding giving priority to the funding and building of affordable housing in Ann Arbor and Washtenaw County.

2. Blaine Coleman - Boycott Israel

Blaine Coleman, P.O. Box 7038, addressed Council regarding boycotting Israel.

3. Sacha Platt - Housing Issues

Sacha Platt, Ann Arbor Resident, addressed Council regarding issues at Avalon Housing. He asked that Council consider suspending financial support to this organization.

4. Mozhgan Savabieasafahni - Boycott Israel

Mozhgan Savabieasafahni, P.O. Box 7038, serenaded Council regarding boycotting Israel.

5. Lily Au - Ann Arbor Housing - Housing First Initiative

Lily Au, 682 Peninsula Ct., addressed Council regarding the need for affordable housing in Ann Arbor. She gave a number of reasons why affordable housing is needed in the community.

6. Arnold Goetzke - E. Stadium Bridge

Arnold Goetzke, 1504 Westminster, addressed Council regarding the Stadium Bridge project. He said that an at-grade road with a stop light at State and an at-grade rail crossing would save over \$10 million from the Road Fund. He asked that Council reconsider the current direction of the Stadium Bridges project.

7. Alan Haber - Library Lot

Alan Haber, 531 Third St., addressed Council regarding the Library Lot. He said that the local Democratic Party passed a resolution on the question of the use of the Library Lot. They asked that Council institute and support a real public process to support the development of a commons or town square in the center of the city.

8. Aaron Miller - Update on Michigan Student Assembly Business

Aaron Miller, 1312 Forest Ct., Michigan Student Assembly City Council Liaison, said that he met with Sue McCormick and Nancy Stone and they identified a couple of areas within the city where there is a need for more student input. There are a couple of committees and taskforces where the city could benefit greatly from having student participation.

COMMUNICATIONS FROM COUNCIL*COUNCILMEMBER TEALL*

Councilmember Teall asked if staff could respond to issues regarding the Stadium Bridges at-grade crossing.

Sue McCormick, Public Services Area Administrator, said that city staff have looked at an at-grade crossing and have had several conversations with the railroad regarding it. The railroad has said in writing that under no circumstances would they consider granting an at-grade crossing. She was not sure if the City could exercise eminent domain against the railroad.

Councilmember Teall advised that members are needed for the Taxicab Advisory Board and encouraged citizens to apply for that board.

COUNCILMEMBER SMITH

Councilmember Smith said that more communication is needed between the City and U of M students.

COUNCILMEMBER RAPUNDALO

Councilmember Rapundalo asked the City Administrator to put together a meeting of the Administration and Labor Committee to update the Council on contract negotiations.

MAYOR HIEFTJE

Mayor Hieftje asked that Ellen Schulmeister, Director of the Washtenaw County Shelter Association, update Council regarding resources provided at the Delonis Center.

Ms. Schulmeister said that Delonis Center added an additional 25 permanent residential beds. The shelter now has a total of 75 beds. They were also able to add an additional rotating shelter to the program this year, which now provides 50 beds in the rotation program. The rotating shelter has housed approximately 35 people a night. The warming center is still in operation; however, it is being run on the first floor in the dining room. There are approximately 30 people a night using the warming center. The shelter can now house up to 170 people a night if the need is warranted.

Ms. Schulmeister added that the family shelters were given vouchers to temporarily house people for one year, freeing up shelter space. The vouchers also included 12-month vouchers for some youth at Ozone House.

COUNCILMEMBER TAYLOR

Councilmember Taylor said that Google recently issued a Request For Information in connection with a project that it is undertaking to select a community to provide a competitive-cost fiber to the home internet service. He informed Council and members of the public that the City is in the process of working hard with partners in the business community through SPARK, other community members and the University of Michigan, in an effort to put together an application to be a municipal partner in the project.

COUNCILMEMBER ANGLIN

Councilmember Anglin said that the lot near the library is not the library lot and is not owned by the library. It is owned by the citizens of Ann Arbor. He reminded the community that the hotel occupancy rate is low and has been for a long time, running at a rate of 45-50% occupancy in the Ann Arbor area. It is hard for businesses to perform at that rate. He added that the proposal for a new hotel would only drain the resources of other hotels in the out-lying areas. It's important to look at these issues and realize where to place resources and time. He encouraged everyone to continue to pay attention to this issue and learn as much as they could about what is going on and for citizens to advise Council as to what they would like to do with the land.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR*BUDGET COMMITTEE*

City Administrator Roger Fraser announced that the Budget Committee met with staff and reviewed a data catalog. The catalog is a public document that provides various pieces of information relating to finance, geographic materials, etc. The catalog is now available online. The URL to the information is www.a2gov.org/data. A link to the web page will be posted on the City's homepage sometime this week.

CENTRAL CAMPUS TRANSIT CENTER

Mr. Fraser said that the City has been working with AATA, the DDA and the University on the Central Campus Transit Center located on the corner of N. University, just west of Church Street. The proposal has been delayed because of improvement costs. Most of those are street improvements on North University. Those kinds of expenditures have not been included in the plan in the near term. The University has been advised of this and they have been advised in the past that if they wanted to put forward the money for those expenses, which includes the waterline replacement under North University, they could. Staff at the University is recommending to the Board of Regents that they proceed with the transit center and that approximately \$450,000.00 in costs that would otherwise be paid by the City be paid by the University with no expectation of payback. Mr. Fraser thanked the University for making that recommendation to the Board of Regents.

STADIUM BRIDGES

Mr. Fraser said that last Fall, an application for a TIGER discretionary grant was made for the reconstruction of two bridges on East Stadium. The estimated total project cost is approximately \$23 million and the City applied for \$21 million in grant dollars. The Federal Government will announce on February 17, 2010 the TIGER grant awards.

MAIN BREAK ON STADIUM BLVD

Mr. Fraser informed Council that a water main break occurred on Stadium Boulevard across from Chrisler Arena last week and caused the closure of Stadium Boulevard. The break was a service line of a fire hydrant. Staff was able to isolate it, shut it off and make the repairs during non-rush hour times and without compromising traffic.

SNOW FALL

Mr. Fraser said that staff have received a lot of compliments about the crews' response to the last storm. Mr. Fraser stated that staff did a nice job and he thanked them for their hard work.

STATE LEGISLATION PROPERTY ASSESSED CLEAN ENERGY (PACE)

Mr. Fraser said that the Property Assessed Clean Energy Act has been voted out of the State House Great Lakes and Environmental Committee to the House floor. This Act would provide the statutory authorization for creating energy programs in our community. It would create special districts where neighborhoods would invest in energy. This would allow them to set up a way to pay back investments over time through tax bills. It's still on the House floor and the fact that it has not been taken off is good news.

Kathy Griswold, Ann Arbor resident, expressed concern with the deletion of language regarding the sign distance on corners and expressed concern with enforcement of the code.

Susan Pollay, representing the subcommittee of the Ann Arbor DDA's Transportation Committee, read a statement from the committee that recommended adopting the taskforce's recommendations of regulation of sandwich board signs without permits on a trial basis.

Carolyn Grawi, from Ann Arbor Center for Independent Living, and a resident of Ann Arbor, said that sandwich board signs are a problem for people who have disabilities. She expressed concern with any ordinance that would place more obstacles on sidewalks.

There being no further comment, the Mayor declared the hearing closed.

Public Hearing on Housing and Human Services Needs for the 2010-11 Washtenaw Urban County Annual Action Plan

A public hearing was conducted on the Housing and Human Services Needs for the 2010-11 Washtenaw Urban County Annual Action Plan. Notice of public hearing was published February 11, 2010.

Carolyn Grawi, Center for Independent Living, said that as the City continues to make plans to move forward and use the CDBG dollars, they should do more regarding housing and human rights activities in the community. She added that 1/5 of the population in this city (approximately 20,000 people) are people who have disabilities of various natures. She asked that the City continue to maintain and improve what already exists in the city.

Daniel Mack, Board of Directors member of the Michigan Itinerant Shelter System-Interdependent Out of Necessity (MISSION) pointed out that the old YMCA was torn down and a parking lot put in its place. Council should address the need for more affordable housing for low-income families and replace the YMCA and include more affordable housing for low-income families.

Ruth Blackburn, 924 Northwood Street, representing Food Gatherers, said that Food Gatherers provides surplus and low-cost purchased food to more than 150 community agencies throughout the county, half of which are in Ann Arbor. 88% of the food distributed by these agencies comes from Food Gatherers. People who have never in their lives needed food assistance are now seeking that assistance. She said to keep in mind the rising rate of food and security in our town when planning and funding human service needs.

Beth Adams, Director of Ann Arbor Meals on Wheels, said that Meals on Wheels provide meals six days a week, Monday through Saturday, to homebound Ann Arbor residents who cannot cook for themselves. 97% of their clients report that the meals they receive are their most important source of nutritious foods.

Ellen Schulmeister, Washtenaw County, thanked Council for helping with housing, homelessness and food service in the community. Housing that is affordable at all levels of the community is crucial to ending homelessness. She asked that the City continue to prioritize and plan for permanent supported housing. The 60 "Y-Units" that were lost in the past are still needed in the community. She asked that this be made a priority in the 2010 planning. Temporary housing will still be needed for people to access quickly when they become homeless.

Carolyn Hastings, Executive Director of the Housing Bureau for Seniors of the University of Michigan Health System, said that cutting support to agencies connected to the University of Michigan Health System might seem to be an obvious way to save money, however, outside funds are still needed to meet their match to the health system. The funding they receive from the City and the County is very critical.

Kimberly Cummings, Executive Director of the Women's Center of South Eastern Michigan, said that they offer a safety net of critical services for people who are experiencing emotional and financial crises. They provide low cost mental health counseling, divorce support services, financial education, legal consultations and job coaching to approximately 600 people each year. An additional 3000 community members call for referrals to other essential services such as housing, food, medical care, etc. The calls for help are more plentiful; waitlists are growing; and struggling clients require more frequent and intensive services.

Brad Mikas thanked Council and the City for supporting affordable housing. He said that there was an item on the Planning Commission's agenda that deals with affordable housing. A developer has approximately \$200,000.00 that should have gone to affordable housing, but through various factors and reasons, the City has postponed the payments. The proposed PUD he believed is being postponed for an additional two years. The project started in 2006. The City should have received \$300,000.00 in affordable housing funds, but because it was delayed, the final payment would not be due until 2012.

Michael Apple, Executive Director of Avalon Housing, thanked the City for support over the years. Avalon currently owns and manages 324 units throughout Washtenaw County, 282 of which are in the City of Ann Arbor. Their wait list has been opened in 2009 for the first time in 5 years. It was opened for two weeks, and they received 505 applications. There are typically 25-30 vacancies each year.

Jim Mogensen, 3780 Green Brier, said that Housing and Human Service funding is only 1.7% of the General Fund budget. Human services have been out-sourced and the nonprofits are now responsible for the social safety net, in many cases at the City level and this is happening throughout the country. The budget is not linear and the problems that the City is facing are correlated with everything else; all the various funders and foundations are having the same problems. It's not just that they need to absorb the amount that the City needs to come up with, but they are also absorbing the amount of money that is not available from other funding sources. He added that this would impact the social safety net and would come back into the regular budget, in police services, jails and other ways that the City would have to fund.

Thomas Partridge, 4220 Eyrie Dr., supported what previous speakers said on subjects pertaining to housing and human services needs planning.

There being no further comment, the Mayor declared the hearing closed.
