- DTE Electric Company requests Michigan Public Service Commission approval to reconcile its Transitional Reconciliation Mechanism associated with the disposition of the City of Detroit Public Lighting System for the period of August 1, 2013 through December 31, 2014.

PARTICIPATION: Any interested person may attend and participate. The hearing site is accessible, including handicapped parking. The Michigan Public Service Commission (Commission) will hold a public hearing to consider DTE Electric Company's (DTE Electric) March 27, 2015 application, which seeks approval to reconcile the Company's Transitional Reconciliation Mechanism (TRM) plan for the 17-month period beginning August 1, 2013 through December 31, 2014. DTE Electric represents that the Company incurred a total TRM under-recovery ending balance of \$15,474,238. On July 11, 2013, the Commission authorized DTE Electric to defer for accounting purposes the net incremental revenue requirement associated with the transition of the City of Detroit Public Lighting Department ("PLD") electric distribution business and transfer of PLD customers to DTE Electric. DTE Electric seeks Commission approval to: a) reconcile the Company's TRM under-recovery ending balance of \$15,474,238; and b) authorize a proposed TRM surcharge of \$0.001332/kilowatt-hour (kWh) to be applicable to all customers from October 1, 2015 through December 31, 2015, as described in its application.

Any person wishing to appear at the hearing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter becomes public information, thus available on the Michigan Public Service Commission's website, and subject to disclosure. Please do not include information you wish to remain private.
