Our firm represents Exclusive Brands, LLC (“Exclusive Brands”). Pursuant to section 401(1)(k) of the Medical Marihuana Facilities Licensing Act, 2016 PA 281, MCL 333.27401(1)(k) and Emergency Rule 19 of the rules filed with the Secretary of State on December 4, 2017, this letter is to inform you that Exclusive Brands submitted the Step One Pre-Qualification application to the Department of Licensing and Regulatory Affairs (“LARA”) on February 15, 2018.
