City of Ann Arbor Public Works Unit has historically purchased safety and personal protective equipment on an asneeded basis. The anticipated safety purchases for FY2026 are projected to total approximately \$25,000.00, resulting in a purchase order request by the Public Works Unit.

An unusual or compelling urgency exists.

The recommended vendor for referenced safety equipment is Safety Solutions Inc., a Michigan based vendor with a broad selection of in-stock inventory. Procurement of safety and PPE has not proven economically feasible for other vendors based upon limited inventory and/or geographical location.

What activities have already occurred prior to submitting this request? Discuss what other products and services in the market were reviewed and why they didn't fulfill the need. Has the vendor already done any work related to this project or purchase?

Public Works Assistant Manager explored cooperative purchasing opportunities without success as the vendors awarded in all discovered cooperatives lack the appropriate offerings and/or include shipping costs that mitigate any cost savings.

Additionally, many of the cooperative purchasing contracts for safety equipment and PPE are awarded to companies in which safety equipment is not their primary business, but rather general inventory with limited offerings for specialized items.

Safety Services Inc. has continued to offer competitive pricing while offering the widest variety of safety equipment found in the State of Michigan. Additionally, freight has been minimal and often waived based upon the geographic location of the vendor.

Based upon competitive pricing exploration, the Public Works Assistant Manager recommends the City of Ann Arbor Public Works Unit procure safety and PPE for FY2026 through a purchase order with Safety Services Inc., created under the best source justification.
