PUBLIC COMMENT - GENERAL (3 MINUTES EACH)

Kai Petainen, resident, spoke about the FOIA conversation at City Council and expressed his disappointment that some Council Members are not complying with FOIA.

Jaime Magiera, Ward 4, spoke about his work with the Washtenaw Biking and Walking Coalition and stated he did not mean to offend anyone with his remarks. He stated the WBWC wants to work collaboratively with the City.

A resident of Ward 4 named Adam spoke about bicycling in the City.

Ed Vielmetti, Ward 4, spoke about the City's new guest services desk and expressed his concern regarding the amount of data that is being collected. He stated there could be privacy concerns with FOIA.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER GRISWOLD

Councilmember Griswold stated she is not in violation of the Freedom of Information Act. She stated that she has asked the City Attorney for clarification on FOIA rules, but that does not mean she is in violation.

(Councilmember Smith left the meeting at 11:18 p.m.)

COUNCILMEMBER HAYNER

Councilmember Hayner followed up on Mr. Vielmetti's comments and stated he too has concerns about the amount of data being collected at the City's front desk. He said he does not think residents should be photographed and he doesn't think a record should be kept of visitors.

COUNCILMEMBER RAMLAWI

Councilmember Ramlawi stated he would be bringing forward a resolution regarding the 415 W. Washington property.

COUNCILMEMBER BANNISTER

Councilmember Bannister stated she is also not aware that she is not complying with FOIA. She said some communications that Councilmembers have are political and outside of City business. She said an overreach of FOIA could have a chilling effect on First Amendment rights.
