That in the case of BBA24-0003, the appeal of the Building Official's decision that the reduced fixture clearance of the sink at 1422 Macgregor Lane is granted relief from section P2705 of the 2015 Michigan Residential Code, and the Building Board of Appeals reverses the Building Official's decision for the reason that:

The applicant has proposed an equal or better form of construction but only insofar that one of the two lavatories provided the one minimally required meets the standard of the code. Additionally, in granting this approval, the appeal shall not for the basis for a precedent in future similar appeals.
