- 2. Project Name: Ductless Heat Pump Installation with Integrated Venting

- Scope of Work: This residential project demonstrates our ability to deliver clean energy upgrades aligned with state electrification goals through the installation of a high-efficiency ductless heat pump system. The indoor unit was located above the garage on the second floor and paired with a Carrier heat pump, mounted on a Quick Sling riser rack for elevation and stability. A 50-foot lineset was installed to connect indoor and outdoor components, and a condensate drain was routed to the home's exterior. The electrical scope included a new whip and disconnect, installed in full compliance with local code.

In addition to the HVAC upgrade, the project involved removing the existing microwave and installing a homeowner-provided Frigidaire vented microwave, with full roof venting and custom duct fabrication. Materials included a 4x10x6 ST boot, 6" collar, sixinch pipe and elbows, R8 duct wrap, and flexible ducting to ensure proper exhaust and insulation.

- Scope of Work: This residential installation involved a multi-zone Carrier heat pump system designed to improve year-round comfort and energy efficiency across distinct areas

of the home. The system included a Carrier heat pump paired with a Carrier air handler and two Carrier ductless head units to serve separate interior zones.

The air handler was installed in the attic and connected to a newly fabricated supply duct system with all new R-8 insulated flex ducting, and the condensate line was routed to the exterior. A fan coil unit was equipped with a drip pan and wet switch (Model #6HK3060) for moisture monitoring, and return air was reconnected to existing ductwork. The ductless heads were wall-mounted, with linehide used for all exterior linesets to ensure clean, weather-protected routing.

Two 25-foot linesets connected the ductless heads to the heat pump, and the system was powered using an existing 220V circuit. Equipment was strategically placed with the 2.5-ton air handler located in the attic and a 1-ton ductless high wall unit in the garage to optimize zone-specific heating and cooling.

This project is a strong example of our ability to deliver multi-zone HVAC solutions that integrate ducted and ductless components while maintaining energy efficiency, clean aesthetics, and code-compliant performance in residential environments.
