**Trische' Duckworth, LLMSW Executive Director/Founder of Survivors Speak –*

Proposal to install a BLM mural in the City of Ann Arbor at Fourth Ave/Ann St for the African America Festival. This mural in the Community will allow all to see and know that black lives matter and that we are present in a world that sometime tries to push black lives to the back burner. Need to understand that all should take the time to notice and see who we are, as a people. These murals are going up all over the United States and currently in the City of Ypsilanti, which will be painted this upcoming Saturday and Sunday at S Washington Street and down into the Riverside Park off of Cross Street. Use of the traditional BLM staple design "yellow" paint will be used.

Our goal is to push programming and do certain Community activities onsite. We want to use this platform to bring the Community together about this very serious conversation and the need, as a community to push it forward. Black lives enhance the lives of black citizens across the country and here in the City of Ann Arbor; one of the most elite cities in the nation, Ann Arbor can achieve an amazing feat by installing this mural programmed into the community to uplift the community. This platform will help make black lives better; from education and cultural to legislative changes – this is our goal.

City Staff will review City Code for a more permanent mural rather than the chalk paint (temporary). Two murals are proposed Main/Fourth Ave and Fourth Ave/Ann St. This will be a permanent install; perhaps a conversation with City Council for their opinion and acceptance. No need to install a mural that will go away, as this divide has been in existence for too long time. We ask your support to remove this barrier and have a conversation with City Council on the use of asphalt grade paint similar to the City of Ypsilanti). This will be a two-step process to change the code to allow for none chalk drawing in the ROW.
