
RESOLUTION TO APPROVE JEWISH COMMUNITY CENTER OF WASHTENAW COUNTY FINAL PHASE PUD

* RESOLVED, That City Council approve the Jewish Community Center of Washtenaw County Final Phase PUD.



JEWISH COMMUNITY CENTER PRELIMINARY AND FINAL PHASE PUD

AN ORDINANCE TO AMEND THE ZONING MAP BEING A PART OF CHAPTER 55, TITLE V OF THE CODE OF THE CITY OF ANN ARBOR.

The City of Ann Arbor ordains:

<u>Section 1</u>. THE ZONING MAP, which, by Section 5:3 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Commencing at the East 1/4 corner of Section 9, T3S, R6E, Pittsfield Township, Washtenaw County, Michigan; thence along the east line of said section N 1 - 18' W 1290.58 feet; thence S 87 - 00' W 347.09 feet; thence S 83 - 10' W 135.0 feet for a PLACE OF BEGINNING; thence S 1 - 07! E 507.20 feet; thence S 85 - 07! W 100.70 feet; thence S 5 - 30' E 139.0 feet; thence Westerly along the arc of a circular curve concave to the North, radius 829.43 feet, chord bearing S 38 - 00' W 217.96 feet; thence N 7: - 51' W 69.44 feet; thence Northerly along the arc of a circular curve concave to the West, radius 275.55 feet, chord bearing N 4 - 39' - 30" 127.01 feet; thence N 8 - 40' W 63.0 feet; thence N 41 - 08' E 80.0 feet; thence N 71 - 42' E 67.58 feet; thence N 85 - 40' E 62.0 feet; thence N 2-33' W 130.0 feet; thence N 87 - 27' E 60.0 feet; thence S 2 - 33' E 130.0 feet: thence N 85 - 40' E 152.0 feet to the Place of Beginning, being a part of the NE 1/4 of said Section 9, Pittsfield Township, containing 6.0 acres of land more or less,

in the City of Ann Arbor, Washtenaw County, Michigan as Preliminary and Final Phase PUD (Planned Unit Development) for use as a 16,016-square foot community center, 3,552-square foot nursery school, a 7,500-square foot elementary school and mechanical space, for a total of 28,180 square feet, as shown on the Jewish Community Center Preliminary and Final Phase PUD Plan.

<u>Section 2</u>. This ordinance shall take effect and be in force on and after ten days from legal publication. Public access easements, as shown on the PUD plan, are to be recorded with the deed for the proposed development and they are to grant the general public the right to access Clinton Park through the Jewish Community Center property (Clinton School).
