*Unarmed Response Public Forum:
S. Carter reported on her meeting and notes with Professional Sector Consultants (PSC) on Unarmed Response regarding inclusion of*

under-served communities. S. Carter explained there are still unanswered questions that need to be addressed and the commission will have to wait until the report comes out. CM Song added the success of the program lies with the City and PSC is not the final decision makers. They collect the information and the City will design the program. IT Generated Reports:

M. Othman request to meet with IT to review how data generated from AAPD can be standardized for Information Managers to write their reviews and recommendations on complaints.

Report from Council:

CM Song reported the City authorized settlement of Rasiel Alvarez-Rodriguez v. City of Ann Arbor. The Council discussed construction contract for the East Medical Center Drive Bridge Rehabilitation and Widening Project. Council members visited Delonis Center last week to get an understanding of the increase in needs, now that warming centers are opening up and colder weather is here. The federal relief money for eviction, protections and avoidance ended in September and hundreds of evictions cases are in the courts now.

New Police Chief Search

F. Todoro-Hargreaves reported the City is currently working on a contract with Baker Tilly, once the contract is approved Baker Tilly representative will reach out to ICPOC and the commission will work together in the search process. F. Todoro-Hargreaves will give the commission an update.
