The Michigan Public Service Commission (Commission) will hold a public hearing to consider DTE Electric Company's (DTE Electric) May 14, 2015 application, which seeks approval of DTE Electric's reconciliation for its 2014 EO plan year, the performance incentives, and the associated proposed tariffs. DTE Electric represents that based on the operation of the surcharge during 2014, the Company has calculated a net overrecovery of \$14.4 million. DTE Electric is proposing to carry forward into 2015 the calculated cumulative overrecovery on a customer class basis and use it as beginning balances for the 2015 reconciliation.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscdockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in

Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by July 2, 2015. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon DTE Electric's attorney, Michael J. Solo, Jr., DTE Electric Company, One Energy Plaza, Detroit, Michigan 48226.

Any person wishing to appear at the hearing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter becomes public information, thus available on the Michigan Public Service Commission's website, and subject to disclosure. Please do not include information you wish to remain private.
