Northville	Thursdays, 8am-3pm	<p>NO MOVING VEHICLES WILL BE PERMITTED IN THE MARKETPLACE AFTER 7:30 AM OR BEFORE 3:00 PM! If the Market Manager officially closes the Market due to threatening weather or an emergency situation, vehicles may enter to load only after customers are safely out of the area.</p> <ul style="list-style-type: none"> • No early departures. Once you have committed to the Market, you are required to stay until 3:00. Vendors moving vehicles into the Marketplace to load before 3:00 will receive one verbal warning. For each violation thereafter, the vendor will be subject to suspension (or may be suspended) from the Market.
Ypsilanti Farmers Markets (Downtown & Depot Town)	Saturdays 9am-1pm; Tuesdays 2-6pm	<p>All vendors are expected to arrive at the market at or before 30 minutes prior to the market and prepared to sell the whole four hours of each market day unless completely sold out or vendor has made prior arrangements with the Market Management. Please call the Market Management if you are going to be late or an emergency arises. Leaving early without prior arrangements or being sold out will automatically result in a violation.</p> <p>Violations of these policies or generally good business conduct will result in:</p> <ol style="list-style-type: none"> 1) A verbal warning from the Market Management 2) A written warning from the Market Management (if violation continues or occurs again) 3) Written notice of removal from the market signed by Market Management (if violation continues or occurs again)

The expectation of the public is that the market ends at 2:00 p.m. Only the Market Manager or a representative can close the market at any time other than that which is scheduled. Vendors are to end sales at 2:15 p.m. and must vacate the market area by 3:30 p.m. Departure not approved by the Market Manager may result in disciplinary action, as outlined in section 10.c. Limited pack-up activity will be allowed on-site, but each vendor will maintain a display and availability until 2:00 pm.</p> <p>10.c) The Market Manager shall have the authority to oversee and enforce the market rules and has the right to refuse a vendor's participation at any time for any reason.</p>

You may be relocated near an exit in these cases.

The time of opening and closing may be changed or regulated by the Royal Oak Farmers Market Committee at the request of the Market Master, as conditions warrant. Special market days may be held with approval of the Royal Oak Farmers Market Committee. All vendors shall adhere to the posted hours of operation.</p> <p>G.
