A motion was made by Commissioner Laramie and seconded by Commissioner Buzzard to recommend purchase of a conservation easement on the property identified in application ID 2022-02 in Northfield Township, approve a participation agreement with the Washtenaw County Parks and Recreation Commission and Northfield Township, and appropriate funds, not to exceed \$432,067.00, from the Open Space and Parkland Preservation Millage proceeds. Motion passed upon unanimous vote.

A motion was made by Commissioner Bloomer and seconded by Commissioner Johnson to recommend purchase of a conservation easement on the property identified in application ID 2018-15 in Northfield Township, approve a participation agreement with the Washtenaw County Parks and Recreation Commission and Northfield Township, and appropriate funds, not to exceed \$465,693.00, from the Open Space and Parkland Preservation Millage proceeds. Motion passed upon unanimous vote.

A motion was made by Commissioner Armstrong and seconded by Commissioner Laramie to recommend City participation with Ann Arbor Township in the acquisition of a conservation easement on the property identified in Application ID 2025-02, approve a Participation Agreement with Washtenaw County Parks and Recreation and Ann Arbor Township, and approval of the contribution of funds not to exceed \$130,00000 from the Open Space and Parkland Preservation Millage. Motion passed upon unanimous vote.

A motion was made by Commissioner Armstrong and seconded by Commissioner Buzzard to decline City participation with Scio Township in the acquisition of a conservation easement on the property identified in Application ID 2025-01. Motion passed upon unanimous vote.
