Hi Mike –

We do! We have the website: www.a2gov.org/2022CommunityClimateActionMillage which contains the two year budget (at the bottom of the page) and I'm about to put some more detail on the website so maybe wait to check until later tomorrow for a bit more detail.

In terms of grants, I'm submitting one to design a district geothermal system next Tuesday, I've got one in to help low-income residents invest in energy efficiency and electrification (we'll hear about that in the coming weeks), we are looking for federal funding for our landfill solar project to help cover some increased costs due to inflation (and a U.S. Department of Commerce mistake made earlier this year), and we are looking to apply for a Public Service Commission grant to help cover some of the upfront costs of electrification and microgrids. I'm also working on some requests for information, which are precursors to federal funding opportunities, where U.S. agencies ask for feedback before they write their funding proposals. I'm focusing on RFI's where I can provide feedback about grid resilience and investments in grid modernization.

Hello Neighbors,

I attended a TC 1 meeting at the Westside library branch this past week. We've been on this Packard journey for years now to no reasonable resolve. My biggest observation from the meeting was to validate that our city has been "hi-jacked" by the Planning Commission (appointed by the mayor) and City Council is either complicit or complacent and has relinquished all common sense. As mentioned before by many others outside this group, this TC 1 Travel Corridor rezoning in theory is all well and good. Yet supporting groups of TC 1 keep asking us to support their ideas by creating new millages. This latest transit millage may just push many over the already unaffordable edge of staying in this community. By the way I counted over 200 EMPTY busses around SE Ann Arbor over the summer and now fall. What are we paying higher taxes for?

If any of you are out and about the Washtenaw or Ellsworth or Stadium corridors at all, it is only going to get worse if the TC 1 passes in full capacity. More dense building right on the street, more bike lanes, more street businesses being bought out for development, etc. as we're being marketed as the "best place to live and work". When issues of infrastructure came up at the TC 1 meeting, there were supporters that had no reference that the sewage system in this city is not in great shape and developers could "just put in bigger pipes".

CHAPTER THREE – ETHICS OMBUDSPERSON

Section 3 – 1. The [chief executive officer or other designated officer if the local unit does not have a chief executive officer], with the advice and consent of the [governing body] shall designate an Ethics Ombudsperson (EO) for the [type of unit].

Section 3 – 2. The EO may recommend to the [type of unit's governing body] that an advisory opinion be sought from the attorney for the [type of unit] regarding any requirement of this ordinance and its application to the officers and employees of the [type of unit].

Section 3 – 3. The EO shall promptly advise the governing body of the [type of local unit] of any problems encountered in the implementation of the ordinance and as to any recommendations that he or she may have for improvement of the ordinance. The EO shall perform such other duties as may be assigned by the [governing body].

Background information:

In my 3+ years on council I have run across many situations where a constituent has exhausted all of their avenues in dealing with the City of Ann Arbor on an issue. With equal frequency, I have seen situations where residents have conflicts with each other, and the city does not have the authority or mechanisms in place to facilitate a solution. As we continue to create through policy and practice situations where a resident is placed in conflict with the city, in many cases, the resident's only recourse is through the courts, an expense that many (most) cannot bear. This is not right, and it reeks of inequity. A solution is to create an office of the Ombudsperson, to mediate and guide residents in their disputes with the city. I would also charge the office with mediating disputes between residents that fall outside of or are tangential to enforcement actions from Community Standards or the AAPD (for example).

Please provide a Resolution to create an Office of the Ombudsperson for the City of Ann Arbor, and please provide estimated start-up and ongoing costs for the office.
