Tom Partridge, Ann Arbor resident, addressed Council regarding the election of Mark Schauer for Governor. He also talked about expanding access to affordable housing, human rights and public transportation.

2. Jeff Hayner - Barton Drive Sidewalk Special Assessment (DS-2)

Jeff Hayner, 1807 Pontiac Tr., spoke in support of the proposed Barton Drive Sidewalk Special Assessment and expressed concern with the cost for the construction.

3. Blaine Coleman - Boycott Israel

Blaine Coleman, Ann Arbor resident, urged Council to pass a resolution calling for a boycott of Israel.

4. Mozghan Savabiehshahani - Boycott Israel

Mozghan Savabiehshahani, Ann Arbor resident, addressed Council regarding crimes against children in Israel, including one U.S. citizen.

5. Kermit Schlansker - Stop Building Houses

Kermit Schlansker, 2960 Marshall, spoke against the high cost of energy needed to operate new homes.

6. Henry Herskovitz - Lavon Affair: When Israel Firebombed U.S. Installations

Henry Herskovitz, 404 Mark Hannah, addressed Council regarding an attack on U.S. property by Israel.

7. Changming Fan - LDFA-Jobs-Manufacturing

Changming Fan, President of TiniLite Inc., thanked Council for creating a model of volunteerism. He expressed concerns with the LDFA and their job creation numbers.

8. Carolyn Grawi - Zoning Research Park Drive

Carolyn Grawi, 1490 Northbrook, addressed Council regarding the proposed rezoning of Research Park Drive. She urged Council to utilize this opportunity to improve accessibility, including sidewalks, on Research Park Drive and access for public transportation.

CC COMMUNICATIONS FROM COUNCIL**COUNCILMEMBER LUMM**

Councilmember Lumm informed Councilmembers that she would be sponsoring a proposed Charter amendment to address the City's eligibility requirements for office for both elected and appointed officials. Councilmember Lumm stated she would have this ready for July 21, 2014 City Council agenda.

Councilmember Lumm announced that a citizen participation meeting for residents in the 1st and 2nd Wards was scheduled for July 10, 2014, 7 p.m., at the Plymouth Road Holiday Inn regarding the development of 110 acres of land at Nixon and DhuVarren Roads by Toll Brothers developers. Comments can also be made by going to the Toll Brothers website at www.TollBrothers.com.

COUNCILMEMBER BRIERE

Councilmember Briere said that the Toll Brothers development at Nixon and DhuVarren Roads would be discussed at the Planning Commission Work Session scheduled for July 8, 2014 as well.

COUNCILMEMBER ANGLIN

Councilmember Anglin spoke about the term "health, safety and welfare" for residents and that this needs to be remembered. He expressed concern about continued building in the floodplain.

COUNCILMEMBER TEALL

Councilmember Teall requested that the Rules Committee review the rules regarding a motion to Table. She asked the Rules Committee provide guidance to moderate the use of this motion. Councilmember Teall noted that a previous use of the motion to table, which ends all discussion, came before all members had a chance to speak. She stated this is not consistent with an open and transparent debate.

MC COMMUNICATIONS FROM THE MAYOR

Mayor Hieftje welcomed Skyline and Huron High School students to the meeting.

Mayor Hieftje updated Council on the growth of the number of people using the facilities at the Delonis Center who are not Washtenaw County residents. He said that number has been growing year by year and the use by non-residents was up to 40% last year and could rise to 50% this coming winter. Mayor Hieftje stated he met with Ellen Schulmeister and Brian Campbell, Director of the Shelter Association Board and Kirk Profit, the City's lobbyist, to discuss the issue.
