IT IS THE ORDER OF THE COMMISSION THAT THE FOLLOWING REQUESTS FOR AUTHORIZATION FOR OUTDOOR ALCOHOLIC LIQUOR BE APPROVED AS INDICATED:

POLKRYST, INC., 122 E. Washington, Ann Arbor, Washtenaw County. Request new authorization for the outdoor sale, service and consumption of alcoholic liquor in an area measuring 25' x 6.5', located 8.5' from licensed premises across the city sidewalk, with the area located on the city sidewalk and totally enclosed by 36" high plastic chain connected to stanchions, to be held in conjunction with 2008 Class C license with Sunday Sales Permit. APPROVED WITH THE PROVISIO THAT THE LICENSEE WILL NOT PERMIT THE SALE, SERVICE OR CONSUMPTION OF ALCOHOLIC LIQUOR OUTDOORS, EXCEPT IN THE DEFINED AREA. FURTHER IT IS THE ORDER OF THE COMMISSION THAT THE LICENSEE BE ADVISED, THAT IN THE EVENT THE BARRIER IS REMOVED FROM THE OUTDOOR SERVICE AREA ON THE CITY SIDEWALK, THAT SAME BE RE-INSTALLED WITH THE SAME DIMENSIONS, IN THE SAME AREA. #421465.
