A CALL TO ORDER

Commissioner Cacciari called the meeting to order at 5:32 pm.

D FIRST PUBLIC COMMENTARY (AGENDA ITEMS ONLY) - (3 Minutes per Speaker)

Nancy Willoughby, artisan vendor, suggested extending middle aisle to sandlot area as a more simple solution for the market building.

Ann Sheppard, artisan vendor, thinks that vendor product balance should be limited at admission, not during permanent stall assignment, which is current practice with artisan vendors.

Debbie Marx, artisan vendor, requested that artisans be allowed to have 2 permanent stalls.

F PRESENTATIONS

G REGULAR BUSINESS (AGENDA ITEMS)**Artisan Vendor discussion**

Market manager suggested assigning the 3 "extra" stalls to artisans on the daily list, but not officially increasing the maximum number of annual stalls for artisans (so if an annual artisan retires now, that stall will go to a daily food vendor until we are back to the total allotted 12). Market manager also suggested having PMAC regularly review rules re: artisan vendors and vendor makeup in general, once every 3 years. PMAC agreed to run these suggestions by farmers market vendors and approve a resolution at the next meeting, after opportunity for comment.

Market building discussion

Commissioners discussed the new market building idea that was presented at the last meeting. There were concerns with flow, and a major renovation to the existing aisle after this past year's construction. PMAC decided that while there were some good things about the suggestion, it isn't the direction we want to pursue at this time. Commissioners agreed to continue to explore adding heat and sidewalks to current structure. Maybe in the future explore a simpler plan for the sandlot area. Await the time to be right to put the current plan out to bid again.
