L. Jackson discussed her meeting with the Washtenaw Equity Partners. The group is working on Front End Prevention-strategy plus research questions to developed and study ways to prevent young people from entering the criminal justice system.

C. Harrision attended the Day of Empathy at the Michigan State Capital, sponsored by Safe and Just organization. Panelist were women who had been incarcerated at Huron Valley Correctional facility. They discussed their living conditions and the challenges they face reentering into the community.

ICPOC Youth Forum

L. Jackson discussed the Youth Forum held at the University of Michigan League-Hussey on Saturday, March 12, 2022. There was a discussion about how young people feel about policing. The theme centered on relationships and participants suggest hosting a similar event with students at their high schools.
