VI.A. Crosswalk Design Guidelines (Cynthia Redinger) (30 Minutes)

Commissioner questions and comments:

- Commissioners requested a clearer explanation of the design process and procedure when determining crosswalk needs. Several asked for clarification on methods to better protect pedestrians and support their needs.
- Concerns were raised about the consolidation of crosswalks.
- There was strong interest in the different types of crosswalk signals and how they could be used to improve the experience for the pedestrian. Commissioners asked about the timeline for updates to pedestrian signals.

#### VII. COMMUNICATIONS

VII.A. Staff Report and Updates (Cynthia Redinger) (10 Minutes)

Commissioner questions and comments:

- Commissioner Jacobson appreciated that focus was drawn to the second crash due to construction and that additional updates will be provided. She requested that information regarding how State policies factor into this situation be included in future updates.
- Commissioner Houk asked Staff to confirm where the document could be found after the meeting.
- Commissioners requested explanations regarding various traffic signals. Concern was raised by Commissioner Houk regarding the use of a flashing yellow arrow. Commissioner Zechar asked if a signalized pedestrian crossing would be added where North University changes to Geddes. Staff confirmed that the crosswalk would be signalized.
- Commissioners discussed the Traffic Calming Program requirements.
