#### SAFETY NOTES

**Safety Update Winter Safety** Winter is here and it's important to remind property owners and residents of the City's ordinance requiring removal of accumulations of snow and ice from adjacent sidewalks, crosswalk ramps and concrete bus stops. The City's ordinance is intended to increase public safety and to allow for safe passage on sidewalks and access for people of all ages and abilities.

According to the ordinance, for residential properties, within 24-hours, accumulations of snow greater than 1 inch must be cleared and any accumulation of ice should be treated with sand, salt or other substance to prevent slip hazards within 18 hours. For non-residential properties, all snow and ice which has accumulated prior to 6 a.m. on a sidewalk adjacent to property shall be removed by the owner or occupant by noon the same day. Crosswalk ramps and bus stops with concrete pads are included in both requirements.

To assist residential property owners with treating ice, the City provides a free sand/salt mixture at the following locations:

- Veterans Memorial Park
- Gallup Park
- Buhr Park
- Burns Park
- Leslie Park

- **A2ZERO Home Energy Advisor hits milestone, helping over 500 Ann Arbor households.** Over 500 Ann Arbor homes have now received customized plans for advancing sustainability, energy efficiency and health through the City's A2ZERO Home Energy Advisor (HEA). Launched in the spring of 2024, the HEA is a free program open to all city residents including homeowners, renters and landlords that performs comprehensive on-site home assessments and provides written reports detailing recommendations and resources individuals can take to save money and make their homes more sustainable. The HEA also provides follow-up support and standalone consultations for specific questions folks may have about things such as appliance replacements, contractor quotes, and more. - **City of Ann Arbor's Green Rental Housing Ordinance Goes into Effect Jan. 6, 2026.** The Green Rental Housing Ordinance requires every rental unit in Ann Arbor to meet a minimum energy efficiency level at the time of its rental inspection. Passed in June 2025, the Ordinance helps ensure that all rental units in Ann Arbor meet a minimum baseline of health, comfort, and efficiency as Ann Arbor works to achieve its A2ZERO carbon neutrality goals while reducing energy costs. - **Expression of Interest: Public Electric Vehicle Charging.** In December 2024, The City of Ann Arbor was awarded the Charging & Fueling Infrastructure (CFI) grant with the goal of building a public electric vehicle charging station network that is affordable, safe, reliable, and widely accessible. The funding allows Ann Arbor to address gaps in charging infrastructure, particularly in low-income areas, multifamily properties, and large retail locations. The City is working with a variety of stakeholders including community organizations, local schools and libraries, residential neighborhoods, and the private sector. As of December 2025, the City is preparing a final Call-Out to invite any possible remaining site hosts to participate in the CFI grant program through our [Intake Form](#) on our website.
- **A2ZERO Ambassador Applications Now Open!** The A2ZERO Ambassador Program is a 12-session training program that hosts community members to explore pathways for advancing local sustainability initiatives, resilience, and carbon neutrality in Ann Arbor. Sessions are held weekly on Wednesday evenings from 6:30 – 8:30 PM. Ambassadors will gain increased knowledge, tools, and resources to discuss sustainability and learn about specific actions they and their communities can take to advance carbon neutrality. ## OTHER

**Winter Compost Pickup.** In 2026, the city will perform once-monthly pickup of compost carts throughout the winter, however no bags or bundles will be collected. Curbside compost cart pickups will take place during the weeks of Jan. 5, Feb. 2 and March 2, 2026. Carts will be collected on residents’ regular solid waste collection day.

The City of Ann Arbor will once again provide drop-off disposal locations for used, undecorated Christmas trees beginning Monday, Dec. 15, 2025, through Monday, Jan. 19, 2026. The city provides four free drop-off locations at city parks. No wreaths, garland, tree stands, lights or decorations are accepted.

The four park locations will be open for Christmas tree drop offs during normal park hours, 6 a.m.–10 p.m. The collected trees will be chipped on a regular basis at the park sites. The drop-off locations are:

- Bicentennial Park (Southeast Area Park) located on Ellsworth at Platt. Trees may be left at the dirt lot north of the basketball courts.
- West Park parking lot off Chapin near West Huron Street
- Gallup boat launch parking lot (not the Gallup livery), entrance on the southeast side of Geddes Road, East of Huron Parkway
- Olson Park parking lot, 1515 Dhu Varren Road, near Pontiac Trail

Trees must have all tree stands, nails, lights, ornaments, tinsel and plastic items removed before drop off. The collected Christmas trees are chipped into mulch or composted. Any lights, metal, glass or plastic ornaments left on the tree can ruin the processing equipment, harm the operators, and spoil the landscaping mulch and compost. Since wreaths and evergreen roping (garland) are generally made with wire or plastic backing, these items should be discarded by placing inside trash carts.

After Jan. 19, 2026, Christmas tree branches, less than 6 inches in diameter, can be cut and placed in compost carts for monthly winter compost service or saved for regular curbside compost service, which resumes in April 2026.

**A2 Snow Match** Snow-covered sidewalks can be hazardous for everyone. But there's something you can do for your neighbors, on either side of the snowbank: [Sign up for the A2 Snow Match program, by becoming a volunteer OR, if eligible, receiving snow/ice-removal assistance](#) to keep walkways passable. The A2 Snow Match program pairs residents in need with nearby neighbors who volunteer to assist with snow removal.



Recipients of volunteer services must be city residents age 55+ or self-identify as having a disability, and without other resources available to help with snow removal (i.e., financial, family, friends or neighbors). Volunteers are matched with homes within about a 10-minute walk of their location. Residents can register to volunteer or receive help! Questions?
